EXPLANATORY MEMORANDUM TO

THE FARRIERS' QUALIFICATIONS (EUROPEAN RECOGNITION) REGULATIONS 2008

2008 No. 646

1. This explanatory memorandum has been prepared by Defra and is laid before Parliament by Command of Her Majesty.

This memorandum contains information for the Joint Committee on Statutory Instruments.

2. Description

- 2.1 This instrument amends the Farriers (Registration) Act 1975 (c.75) to provide for the recognition and registration of farriers from other European Member States so that they can lawfully pursue the profession of farriery in the United Kingdom either in an employed or self-employed capacity on a permanent or temporary basis.
- 2.3 It also amends the Farriers (Registration) Act 1975 ("FRA") to provide for additional appeals to the Disciplinary Committee in relation to registration and makes other amendments consequential to the European Communities (Recognition of Professional Qualifications) Regulations 2007 (S.I. 2007/2781) ("the DIUS Regulations").

3. Matters of special interest to the Joint Committee on Statutory Instruments

3.1 None

4. Legislative Background

- 4.1 This instrument is necessary in order to fully implement into UK law Directive 2005/35/EC on the recognition of professional qualifications.
- 4.2 The European Communities (Recognition of Professional Qualifications) Regulations 2007(SI 2007/2781) which were produced by the Department for Innovation, Universities and Skills (the "DIUS Regulations") and which came into force on 19th October 2007 transpose most of the provisions of the Directive. This instrument appropriately cross-refers to those Regulations and must therefore be read with those Regulations. A Transposition note follows this memorandum indicating which articles of the Directive have been transposed by each set of Regulations. The DIUS Regulations also revoke SI 2002/1597 which previously amended the Farriers Registration Act to implement Directive 1999/42/EEC on the recognition of qualifications in respect of the professional activities covered by the Directives on liberalisation and transitional measures and supplementing the general systems for the recognition of qualifications.
- 4.3 The Explanatory Memorandum to the DIUS Regulations referred to above provides details on the EU scrutiny history.

5. Territorial Extent and Application

- 5.1 The FRA, which these Regulations amend, only extends to Great Britain.
- 5.2 The FRA is devolved in the case of Scotland but Scottish Ministers have agreed to these Regulations implementing the Directive on GB basis. Farriers are unregulated in Northern Ireland.

6. European Convention on Human Rights

The Minister of State for the Department for Environment, Food and Rural Affairs, [LordRooker] has made the following statement regarding Human Rights:

In my view the provisions of the Farriers' Qualifications (European Recognition) Regulations 2008 are compatible with the Convention rights.

7. Policy background

- 7.1 The purpose of Directive 2005/36/EC is to make it easier for qualified professionals to practise their professions in European countries other than their own by simplifying the recognition procedures. It repeals and replaces a number of existing Directives relating to the recognition of professional qualifications including Directive 1999/42/EC which previously gave rise to amendments to the FRA under SI 2002/1597. That SI was revoked by the DIUS Regulations.
- 7.2 The purpose of the FRA is primarily to prevent and avoid suffering by and cruelty to horses arising from the shoeing of horses by unskilled persons; to establish a Council to regulate and register persons engaged in farriery and to prohibit the shoeing of horses by unqualified persons. Section of 18 of the Act defines 'farriery' as meaning "any work in connection with the preparation or treatment of the foot of a horse for the immediate reception thereon, the fitting by nailing or otherwise of a shoe to the foot or the finishing off of such work to the foot;". It is an offence under the FRA (with some exceptions) to carry out farriery unless a person is registered in the Register of Farriers kept by the Farriers Registration Council.

Consultation

- 7.3 DIUS have previously consulted on the Directive and the DIUS Regulations. As the UK government is required to implement the Directive, the consultation on these Regulations did not consult on the principles underlying the Directive or those provisions whose transposition into domestic law leaves no room for discretion at Member State level. The purpose of the consultation was to explain why we are proposing to transpose in the way that we are, and to seek stakeholder views on those parts of the Directive where the UK can choose how to implement them.
- 7.4 We consulted the Farriers Registration Council which is the regulatory body for farriers during the last 18 months about the best way of changing domestic legislation to fully achieve the effects intended by the Directive.
- 7.5 A limited formal consultation on these Regulations was launched on 7 November 2007 and closed on 19 December 2007 with the Farriers Registration Council (FRC), the

Worshipful Company of Farriers (WCF), the UK Horse Shoers Union (UKHSU) and the National Association of Farriers, Blacksmiths and Agricultural Engineers (NAFBAE). Responses were received from the FRC and the UKHSU.

- 7.6 See also the policy background in the Explanatory Memorandum to the DIUS Regulations (SI 2007/2781) which provides a detailed explanation of the provisions of the Directive and information on consultation as concerns the Directive and with UK competent authorities across all the professions as concerns those Regulations.
- 7.7 Concerns raised during consultation on these Regulations centred on the level of competence of temporary service providers. In particular, that the Directive significantly undermines the progress made since the introduction of the FRA in ensuring that all those who carry out farriery in GB have been properly trained and have passed a test of competence as a pre-condition to registration. However the FRC accepted that the introduction of provisions for the registration of temporary service providers was the best way of handling applicants wishing to provide services on a temporary basis.

8. Impact

An Impact Assessment has not been prepared for this instrument as no significant impact on public, private or voluntary sectors is foreseen.
