

**EXPLANATORY MEMORANDUM TO**  
**THE GRANTS TO THE CHURCHES CONSERVATION TRUST ORDER**  
**2008**

**2008 No. 842**

1. This explanatory memorandum has been prepared by the Department for Culture, Media and Sport and is laid before the House of Commons by Command of Her Majesty.

This memorandum contains information for the Select Committee on Statutory Instruments.

2. **Description**

- 2.1 This Order provides the statutory basis for the Government's financial support of the Churches Conservation Trust. The Trust was established in 1969 as the Redundant Churches Fund under provisions currently embodied in the Pastoral Measure 1983. The Trust cares for Church of England churches of historic or architectural interest no longer required for regular worship and for which no suitable alternative use can be found. Government currently provides 70% of the Trust's statutory funding, the remaining 30% being provided by the Church Commissioners.

4. **Legislative Background**

- 4.1 This Order is made in exercise of the powers conferred on the Secretary of State by section 1(1), (2) and (3) of the Redundant Churches and other Religious Buildings Act 1969 ("the 1969 Act"). A draft of the Order is being laid for approval by the House of Commons in pursuance of section 1(4) of the 1969 Act.

- 4.2 Since the establishment of the Churches Conservation Trust as the Redundant Churches Fund in 1969, the Government has provided statutory funding in line with its policies towards preserving and maximising access to the historic built environment. The Trust's main objective is the conservation of the churches in its care and those newly vested by the Redundant Churches Committee of the Church Commissioners. The Trust will also investigate and negotiate for alternate use of the churches where appropriate.

4.3 A revised Funding Order is required due to an increase in annual Grant in Aid for the 2008/9 to 2010/11 period from £3 million to £3,161,806.

## **5. Extent**

5.1 This instrument applies to England and Wales.

## **6. European Convention on Human Rights**

The Minister for Culture has made the following statement regarding Human Rights:

In my view the provisions of The Grants to the Churches Conservation Trust Order 2008 are compatible with the Convention rights.

## **7. Policy background**

7.1 The Government's policy is to financially support the work of the Churches Conservation Trust, in line with its general objectives concerning the conservation of the historic built environment. Churches represent a large proportion of the listed buildings in England. Due to demographic changes and other factors, an average of about 25 Anglican churches per year become redundant, following due process undertaken by the Church Commissioners. While a larger proportion of the churches becoming redundant are either found a new use or are demolished, those considered most architecturally or historically significant are vested in the Trust by the Commissioners.

7.2 While the primary objective of the Trust is conservation of the churches in its care, an increasing number are being considered for alternative use. It is an aim of the Trust that such alternative use would not only reduce the dependence of buildings on the Trust, thus releasing funding for other projects, but would also produce benefits in line with the aims and objectives of other Departments in terms of the provision of community facilities, capacity building and support for volunteering, community cohesion and regeneration. There is encouraging evidence of benefit in these areas.

7.3 Government funding for heritage church buildings has recently been of high profile, with the Church of England actively pursuing a campaign to increase the level of such support.

7.4 In November 2005, the General Synod approved the Church of England's contribution to the Trust for the period 2006/7 to 2008/9, and approval will be sought at the November 2008 Synod for the Church's funding of the Trust from 2009/10 to 2011/12. The Department for Culture, Media and Sport has a funding agreement with the Trust which outlines the Department's requirements for the Trust for the funding period, including how the Trust is expected to

contribute to the Department's Strategic Objectives. The format of a new agreement for 2008/9 to 2010/11 is currently under consideration. Agreements are made jointly with the Church Commissioners, and encompass the Commissioners' targets for the Trust.

## **8. Impact**

8.1 A Regulatory Impact Assessment has not been prepared for this instrument as it has no impact on business, charities or voluntary bodies.

8.2 There is no impact on the public sector.
