**PROBATION**

**The Offender Management Act 2007  
(Consequential Amendments) Order 2008**

*Made* - - - - - *27th March 2008*  
*Coming into force* - - - - - *1st April 2008*

The Secretary of State, in exercise of the powers conferred by section 38(1)(a) and (2)(a) of the Offender Management Act 2007(1), makes the following Order;

In accordance with section 36(3)(d) of that Act, a draft of this instrument was laid before Parliament and approved by a resolution of each House of Parliament:

**Citation, commencement and extent**

1. This Order may be cited as the Offender Management Act 2007 (Consequential Amendments) Order 2008 and shall come into force on 1st April 2008.

2. The extent of any amendment of any provision made by this Order is the same as that of the provision amended.

**Consequential amendments**

3. The enactments listed in Schedule 1 (amendments of Acts) and Schedule 2 (amendments of subordinate legislation: new arrangements for the provision of probation services) to this Order are amended as there specified.

(3) In its application to a probation trust, article 2(1) shall have effect as if for “by 30th April 2007” there were substituted “within one year from the date of the establishment of a probation trust under section 5(1) of the Offender Management Act 2007”.

(4) In its application to a provider of probation services (other than the Secretary of State or a probation trust), in relation to the performance of its statutory functions and the carrying out by it of activities of a public nature in pursuance of arrangements made with it under section 3(2) of the Offender Management Act 2007, article 2(1) shall have effect as if for “by 30th April 2007” there were substituted “within one year from the date on which the provider first entered into arrangements under section 3(2) of the Offender Management Act 2007”.

### **Children Act 2004 Information Database (England) Regulations 2007**

**15.**—(1) The Children Act 2004 Information Database (England) Regulations 2007(**161**) are amended as follows.

(2) In Schedule 3 (persons who may be given access to the database by a local authority), in paragraph 5, the existing provisions become sub-paragraph (1), and after that sub-paragraph insert—

“(2) An officer of a provider of probation services acting in England.”

(3) In Schedule 4 (persons and bodies required to disclose information for inclusion in the database), after paragraph 3, insert—

“4. A provider of probation services (other than the Secretary of State).”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order makes amendments consequential to Part 1 of the Offender Management Act 2007(**162**) (“the OMA 2007”) which contains new arrangements for the provision of probation services. The OMA 2007 places a statutory duty on the Secretary of State to ensure that sufficient probation services are provided throughout England and Wales(**163**) and enables the Secretary of State to make contractual or other arrangements with providers of probation services for the provision of probation services(**164**). The OMA 2007 also establishes probation trusts(**165**). The arrangements in the OMA 2007 are to be brought into force by geographical areas in phases and will replace the arrangements in respect of the National Probation Service for England and Wales contained in Part 1 of the Criminal Justice and Court Services Act 2000 (“the CJCSA 2000”), which place the duty for ensuring sufficient provision of probation services on local probation boards.

This Order amends references in enactments to the arrangements under Part 1 of the CJCSA 2000, such as to “a local probation board” and “an officer of a local probation board”, to include a reference to the new arrangements for the provision of probation services in the OMA 2007. Such amendments to primary legislation are contained in Part 1 of Schedule 1 to this Order and the amendments to secondary legislation are contained in Schedule 2.
