## ROAD TRAFFIC

The A34 Trunk Road (Milton Interchange and Marcham Interchange, Lay-Bys) (Temporary Prohibition of Traffic) Order 2010

Made - - - - 4th May 2010

Coming into force - - 8th May 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A34 Trunk Road, is satisfied that traffic should be prohibited on lengths of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A34 Trunk Road (Milton Interchange and Marcham Interchange, Lay-Bys) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 8th May 2010.

## 2. In this Order:

"the trunk road" means the A34 Trunk Road in the County of Oxfordshire;

"lay-by" means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**);

"an A34 lay-by" means –

- (i) the lay-by in southbound carriageway of the trunk road 130 metres south of Didcot Road overbridge (B4493) south of Milton Interchange (A4130), or
- (ii) the lay-by in the northbound carriageway of the trunk road 200 metres south of Pen Lane overbridge north of Marcham Interchange (A415);

"works" mean the installation of safe havens on the trunk road; and

"a works period" means a period of 8 hours starting at 2200 hours on Tuesday 11th May 2010 or on any subsequent day until 7th November 2011.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in, or wait on, an A34 lay-by.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
