ROAD TRAFFIC

The A3(M) Motorway and the A27 Trunk Road (A3(M) Junction 5, Northbound) (Temporary Prohibition of Traffic) Order 2010

Made - - - - 24th May 2010

Coming into force - - 29th May 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A3(M) Motorway, the A27 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on a length of that motorway and on one of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A3(M) Motorway and the A27 Trunk Road (A3(M) Junction 5, Northbound) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 29th May 2010.

2. In this Order:

"the A3(M)" and "the A27" mean, respectively, the A3(M) Motorway and the A27 Trunk Road in the County of Hampshire;

"the length of northbound carriageway" means the northbound carriageway of the A3(M) between the slip road leading from the eastbound carriageway of the A27 to the A2030 (Havant Road) and the slip road leading from Bedhampton Roundabout at Junction 5;

"the slip road" means the road leading from the eastbound carriageway of the A27 to the A2030 (Havant Road) at A3(M) Junction 5;

"works" mean carriageway repairs and highway maintenance work on the A3(M) and the A27; and

"a works period" means a period of 7½ hours starting at 2200 hours on Friday 4th June 2010 or on any subsequent day until 28th November 2011.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the length of northbound carriageway or the slip road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;

- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
