ROAD TRAFFIC

The A46 Trunk Road (Near Ansty, Warwickshire) (Temporary Restriction and Prohibition of Traffic) Order 2010

 Made
 30 July 2010

 Coming into force
 6 August 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road ("the A46") and connecting roads, is satisfied that traffic on lengths of that road near Ansty in the County of Warwickshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1) (a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A46 Trunk Road (Near Ansty, Warwickshire) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 6 August 2010.

2. In this Order:

"the eastern roundabout"	means the circulatory carriageway of the A46 roundabout east of the M69 overbridge, south east of Junction 2 of the M6;
"the western roundabout"	means the circulatory carriageway of the A46 roundabout west of the M69 overbridge, south east of Junction 2 of the M6;
"the northbound link road"	means the northbound link road from the eastern roundabout to the western roundabout;
"the southbound link road"	means the southbound link road from the western roundabout to the eastern roundabout;
"the works period"	means the period starting at 00.01 hours on Monday 9 August 2010 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the southbound link road.

4. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to proceed in the northbound link road in any direction other than southwards.

5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter the western roundabout at its junction with the northbound carriageway of the A46.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

7. The provisions of articles 3 and 5 shall not apply to any vehicle-

- (i) being used for police, fire brigade or ambulance purposes,
- (ii) proceeding at the direction of, or with the permission of, a police constable, or
- (iii) being used in connection with the said works.
