**The M6 Motorway (Junctions 3 – 3a) (Temporary Restriction
and Prohibition of Traffic) Order 2010**

Made - - - - 06 August 2010

Coming into force - - 13 August 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Motorway (“the M6”), is satisfied that traffic on a length of that motorway between Junction 3 and 3a in the County of Warwickshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) and (7) of the Road Traffic Regulation Act 1984 **(a)**, and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the M6 Motorway (Junctions 3 – 3a) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 13 August 2010.

2. In this Order –

"the motorway"	means the westbound carriageway of the M6 from the centreline of the B4102 Meriden Road underbridge, west of Junction 3, for a distance of 2000 metres in a westerly direction;
"the Regulations"	means the Motorways Traffic (England and Wales) Regulations 1982 (b) ;
"a hard shoulder"	means the hard shoulder, within the meaning of Regulation 3(1)(e) of the Regulations, which is adjacent to the motorway;
"the works period"	means the period starting at 2200 hours on Monday 16 August 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour in the motorway.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the motorway.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

6. The provisions of articles 3 and 4 shall not apply to any vehicle –

(a) being used for police, fire brigade or ambulance purposes; or

(b) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform;

and nothing in article 4 shall apply to any vehicle being used for or in connection with the said works or by a traffic officer in uniform.

7. During the works period, regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Regulations are hereby suspended in respect of a hard shoulder, at such times and to such extent as may from time to time be indicated by traffic signs.
