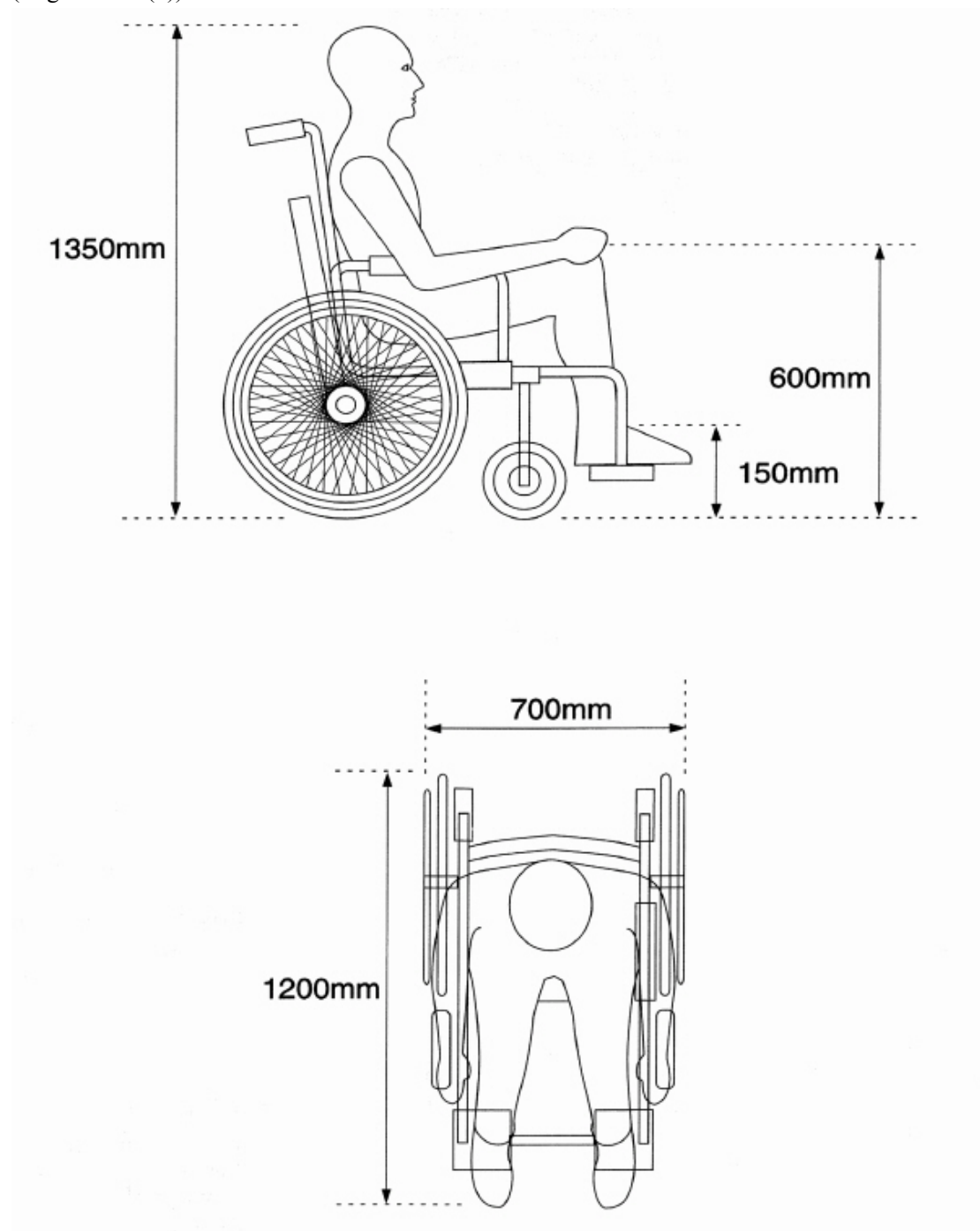

#### Diagram A (reference wheelchair)

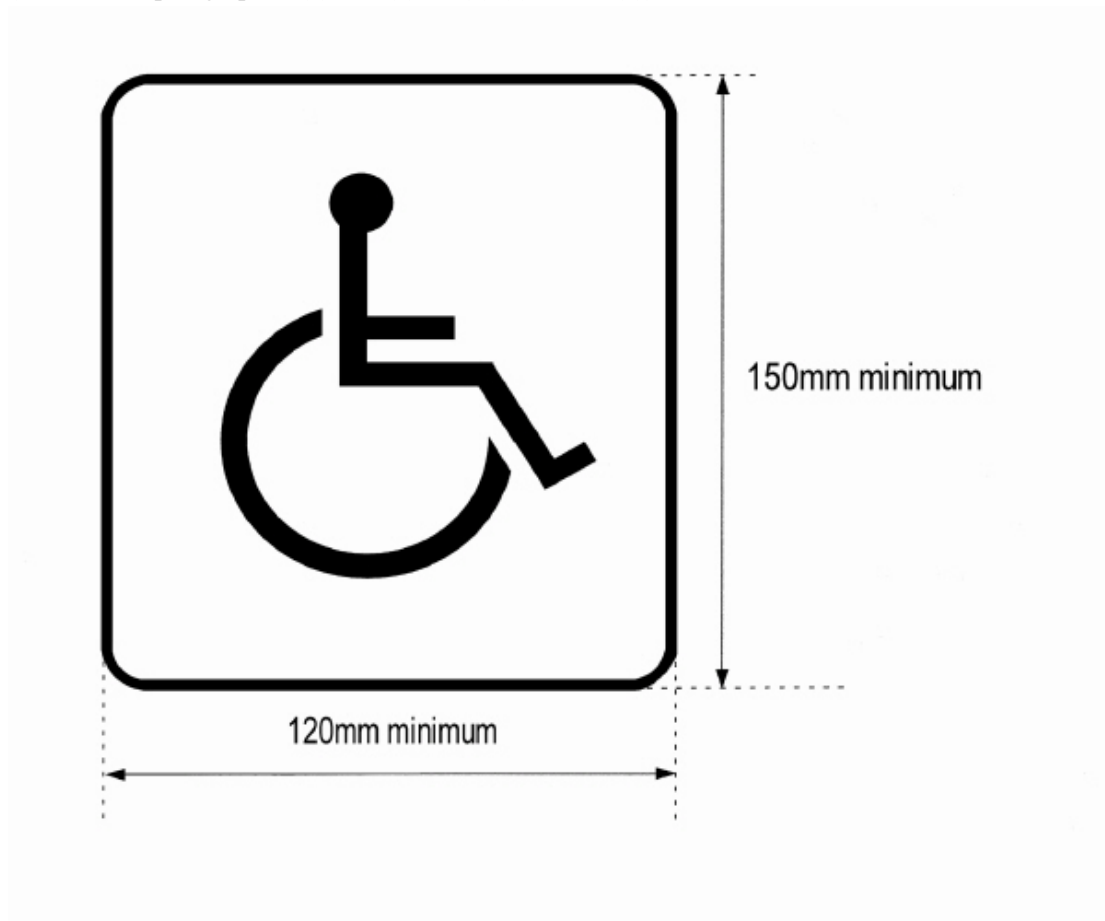

**Diagram B (wheelchair sign)**

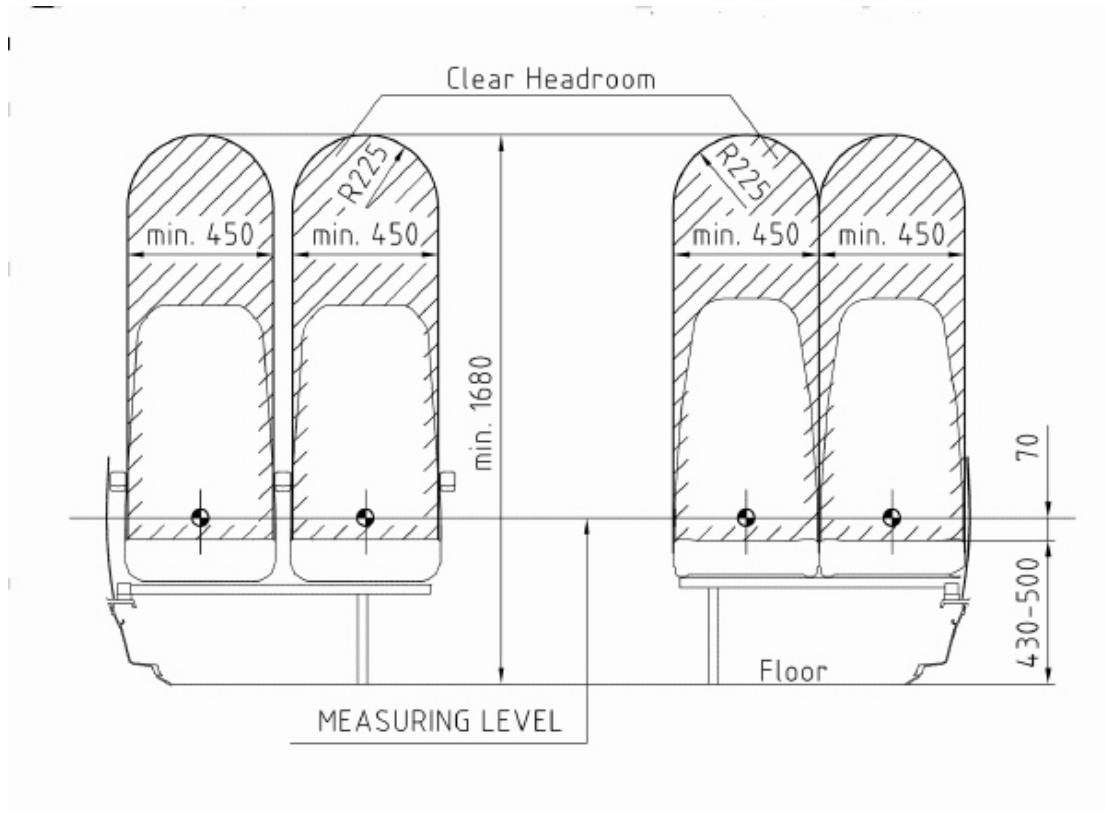

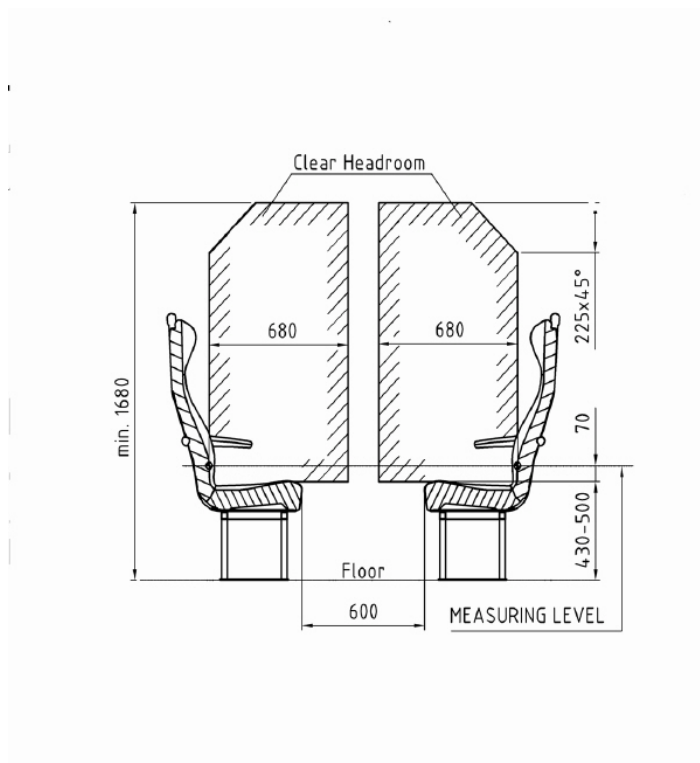

**Diagram C2 (facing seats without table)**

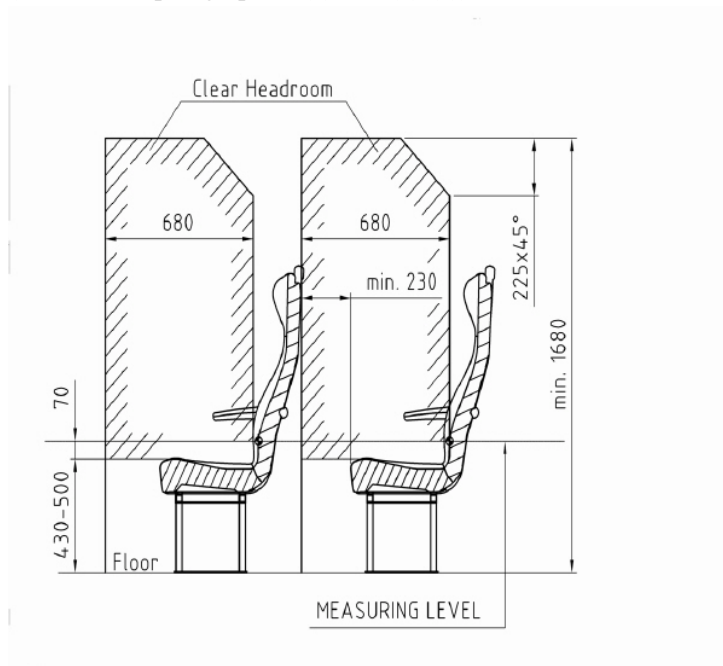

**Diagram C3 (non facing seats)**

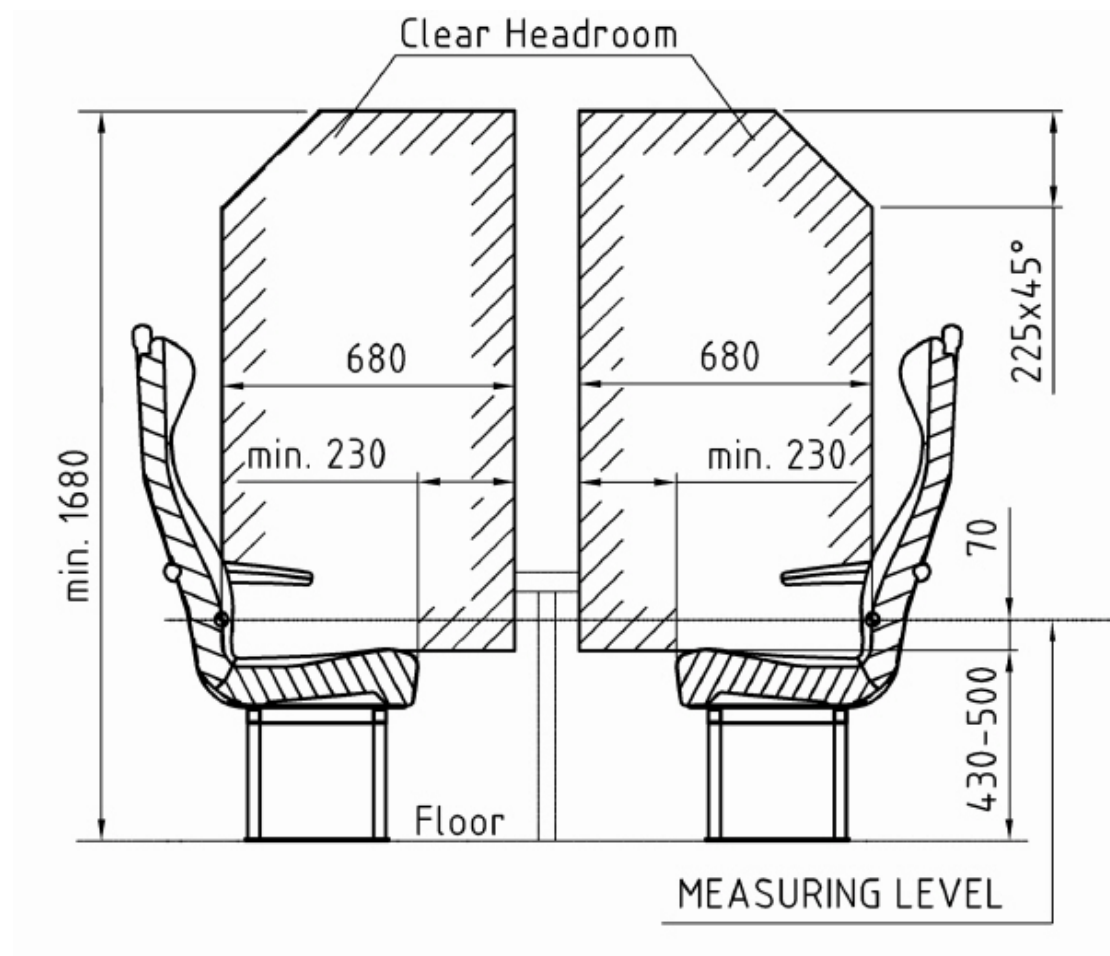

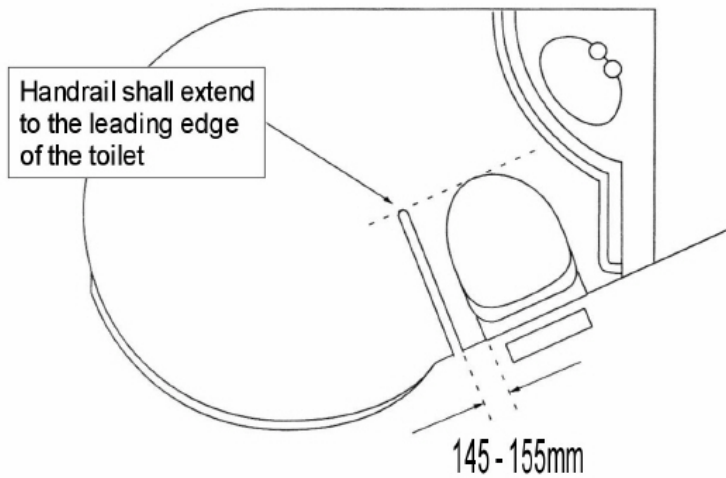


(Note: Minimum clearance of 230 mm required between edge of seat and edge of table to ensure passengers can access and exit seat space standing upright without having to bend their knees).

**Diagram D1 (hinged handrail – plan view)**

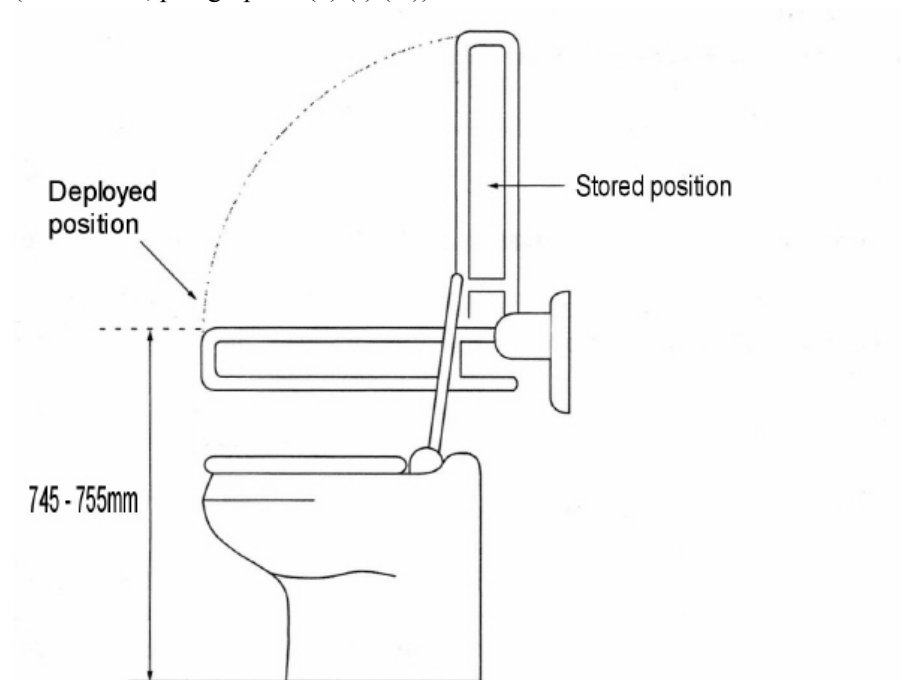
