ROAD TRAFFIC

The A30 and A38 Trunk Roads (Carminow Cross, Bodmin) (Temporary Prohibition of Traffic and Speed Restriction) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A30 Trunk Road and A38 Trunk Road ("the A30" and "the A38"), is satisfied that traffic on a length of that road and slip road at Carminow Cross, Bodmin in the County of Cornwall should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the A30 and A38 Trunk Roads (Carminow Cross, Bodmin) (Temporary Prohibition of Traffic and Speed Restriction) Order 2011 and shall come into force on 20th August 2011.

2. In this Order:

"the first lengths of trunk road" means: (a) the eastbound exit slip road of the A30 at Carminow Cross Junction; (b) the A38 from a point 482 metres west of the centre of the A38 Turfdown Roundabout to its junction with the A38 Carminow Cross Roundabout; and (c) the circulatory carriageway of the Carminow Cross Roundabout;

"the second lengths of trunk road" means: (a) the eastbound exit slip road of the A30 at Carminow Cross Junction from a point 100 metres south of Carminow Cross Roundabout to its junction with that roundabout; (b) the A38 from a point 280 metres west of the centre of the A38 Turfdown Roundabout to its junction with the A38 Carminow Cross Roundabout; and (c) the circulatory carriageway of the Carminow Cross Roundabout;

"the slip road" means the eastbound exit slip road of the A30 at Carminow Cross from the tip of the nosing of the A30 eastbound exit slip road to its junction with Carminow Cross Roundabout;

"the works" mean resurfacing and maintenance works; and

"a works period" means a period of 10 hours starting at 20.00 hours on 22 August 2011 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5 no person shall, during the works period, drive any motor vehicle at a speed exceeding -

- (a) 50 miles per hour on the first lengths of the trunk road; and
- (b) 10 miles per hour on the second lengths of the trunk road.

4.Subject as mentioned in article 6 of this Order no person shall, during a works period, cause or permit any vehicle to enter or proceed in the slip road.

5. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to a vehicle being used for police, fire and rescue authority or ambulance purposes;

6. The provisions of article 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;

(b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

(c) a vehicle being used for or in connection with the said works.

7. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
