ROAD TRAFFIC

The A120 Trunk Road (Great Dunmow to Stansted, Essex) Westbound (Temporary Prohibition of Traffic) Order 2012

 Made
 30th May 2012

 Coming into force
 6th June 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A120 Trunk Road ("the A120") and connecting roads, is satisfied that traffic on that trunk road and on one of those connecting roads in the County of Essex should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the A120 Trunk Road (Great Dunmow to Stansted, Essex) Westbound (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 6th June 2012.

2. In this Order -

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

"Trinity overbridge" means the overbridge to the east of Bassingbourn Roundabout at Stansted Airport, that links the local distributer roundabout to the mid stay car park and the mini roundabout to the A120;

"the trunk road" means the westbound carriageway of the A120 from the tip of the nosing of the exit slip road to the B1256 Stortford Road western roundabout at Great Dunmow to the centre point of Trinity overbridge;

"the slip road" means the A120 westbound entry slip road from the B1256 Stortford Road western roundabout at Great Dunmow;

"works" mean resurfacing and the renewal of road markings;

"a works period" means a period of 10 hours starting at 20.00 hours on Tuesday 12th June 2012 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the trunk road or the slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall,
from time to time, be indicated by traffic signs and shall not apply to a vehicle being used for or in
connection with the works or for traffic officer purposes, or for police, fire and rescue authority or
ambulance purposes.
