The Police and Crime Commissioner Elections (Welsh Forms) Order 2012

Made - - - - 30th October 2012

Coming into force in accordance with article 1(2)

This Order is made by the Secretary of State in exercise of the powers conferred by sections 58(1) and 154(5) of the Police Reform and Social Responsibility Act 2011⁽¹⁾ as extended by section 26(3) of the Welsh Language Act 1993⁽²⁾.

The Secretary of State has consulted the Electoral Commission about this Order in accordance with section 7(2)(hc) of the Political Parties, Elections and Referendums Act 2000⁽³⁾.

In accordance with section 154(2)(b) of the Police Reform and Social Responsibility Act 2011, a draft of this Order has been approved by a resolution of each House of Parliament.

Citation and commencement

1.—(1) This Order may be cited as the Police and Crime Commissioner Elections (Welsh Forms) Order 2012.

(2) This Order comes into force on the day after the day on which it is made.
