**ROAD TRAFFIC**

**The A50 Trunk Road (M1 Junction 24a, Leicestershire)  
(Temporary Prohibition of Traffic) Order 2012**

*Made* - - - - *4th January 2012*  
*Coming into force* - - *11th January 2012*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road (“the A50”) and connecting roads, is satisfied that traffic on lengths of that road and one of those connecting roads, at M1 Junction 24a in the County of Leicestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A50 Trunk Road (M1 Junction 24a, Leicestershire) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 11th January 2012.

2. In this Order –

| “the trunk road”   | means the eastbound carriageway of the A50 from its junction with the link road leading to the northbound carriageway of the M1 at Junction 24a to its roundabout junction with Warren Lane; |
| “the roundabout”   | means the circulatory carriageway of the A50 at its roundabout junction with Warren Lane;  |
| “a link road”      | means the link road leading from the southbound carriageway of the M1 to the roundabout;   |
| “the works period” | means the period starting at 20:00 hours on Monday 16th January 2012 and ending when the said works have been completed;   |

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road, the roundabout, or a link road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave Warren Lane at its junction with the roundabout.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable; or
- (iii) being used in connection with the said works.
