**The Air Navigation (Restriction of Flying) (Bucklebury,
Berkshire) Regulations 2013**

Made - - - - - *23rd July 2013*

Coming into force - - - - - *24th July 2013*

The Secretary of State deems it necessary in the interest of security to restrict flying in the vicinity of Bucklebury, Berkshire, by reason of the visit by the Duke and Duchess of Cambridge and their son that is scheduled to take place there from 24th July 2013.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Bucklebury, Berkshire) Regulations 2013 and come into force on 24th July 2013.

Interpretation

2. In regulation 3 all times referred to are Co-ordinated Universal Time.

Restricted airspace

3.—(1) Subject to paragraph (2), between 0800 hours on 24th July 2013 and 2359 hours on 7th August 2013, no aircraft is to fly below 4,500 feet above mean sea level within the area of a circle having a radius of 1.5 nautical mile whose centre is 512546N 0011150W.

(2) Paragraph (1) does not apply to any aircraft—

(a) flying in the service of—

(i) the National Police Air Service,

(ii) the Metropolitan Police Service,

(iii) the Helicopter Emergency Medical Service, or

(iv) The Queen's Helicopter Flight; or

(b) being operated with the authority of Chief Inspector Stephanie Cook of the Thames Valley Police.

(a) S.I. 2009/3015, to which there are amendments that are not relevant to these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations restrict flying in the vicinity of Bucklebury, Berkshire, during the visit by the Duke and Duchess of Cambridge and their son that is scheduled to take place there from 24th July 2013. The Thames Valley Police has requested these restrictions, which form part of the overall security arrangements for this event. This request has been agreed with the Civil Aviation Authority's Safety and Airspace Regulation Group (SARG) and the Department for Transport.

Full details of the airspace restrictions will be promulgated by NOTAM.
