The Dartmouth-Kingswear Floating Bridge (Revision of Charges) Order 2013

Made - - - - 18th November 2013

Coming into force - - 25th November 2013

The Secretary of State for Transport, in exercise of the powers conferred by section 6 of the Transport Charges &c. (Miscellaneous Provisions) Act 1954(a), makes the following Order:

- **1.** This Order may be cited as the Dartmouth-Kingswear Floating Bridge (Revision of Charges) Order 2013 and shall come into force on 25th November 2013.
- **2.** The tolls that the Company may demand, take and recover for the use of the floating bridge are revised so that those tolls shall not exceed the sums set out in the Schedule to this Order.
 - 3. In this Order—
 - (a) "the Company" means the Dartmouth-Kingswear Floating Bridge Company Limited;
 - (b) "the floating bridge" has the meaning given to that expression in section 2 of the Dartmouth-Kingswear Floating Bridge Act 1988(**b**); and
 - (c) "passenger vehicle" and "goods vehicle" have the meanings given to those expressions in regulation 3(2) of the Roads Vehicles (Construction and Use) Regulations 1986(c).
- **4.** The Dartmouth-Kingswear Floating Bridge (Vehicle Classifications & Revision of Charges) Order 2008(**d**) and The Dartmouth-Kingswear Floating Bridge (Vehicle Classifications & Revision of Charges) (Amendment) Order 2011(**e**) are revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, made in response to an application by the Dartmouth-Kingswear Floating Bridge Company Limited ("the Company"), revises the tolls for which the Company may charge for use of the Dartmouth-Kingswear Floating Bridge (also known as the Dartmouth-Kingswear Higher Ferry).
