# CLEAN AIR, ENGLAND

## The Smoke Control Areas (Exempted Fireplaces) (England) (No. 2) (Amendment) Order 2013

The Secretary of State makes the following Order in exercise of the powers conferred by section 21 of the Clean Air Act 1993<sup>(1)</sup>.

The Secretary of State is satisfied that the fireplace exempted by this Order can be used for burning fuel other than authorised fuels<sup>(2)</sup> without producing any smoke or a substantial quantity of smoke.

### Citation and commencement

1. This Order—
  - (a) may be cited as the Smoke Control Areas (Exempted Fireplaces) (England) (No. 2) (Amendment) Order 2013;
  - (b) comes into force on 25th December 2013.

### Amendment to the Smoke Control Areas (Exempted Fireplaces) (England) (No. 2) Order 2013

2.—(1) The Smoke Control Areas (Exempted Fireplaces) (England) (No. 2) Order 2013<sup>(3)</sup> is amended as follows.

(2) In the Schedule in the entry beginning “Sirius 490 Sigma MF”, after “Sirius 490 Scene MF” insert, “Sirius 790 Sigma MF”.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order amends the Smoke Control Areas (Exempted Fireplaces) (England) Order (No. 2) 2013 ([S.I. 2013/2112](#)) which exempts various fireplaces from the provisions of section 20 of the Clean Air Act 1993 (prohibition of smoke emissions in smoke control areas), subject to the conditions set out in the Schedule.

One entry has been inserted into the Schedule in order to exempt an additional fireplace (the Sirius 790 Sigma MF).

A full impact assessment has not been produced as no impact on the private, voluntary or public sectors is foreseen.
