Citation and commencement

1. This Order may be cited as the Trade Marks (International Registration) (Amendment) Order 2013 and comes into force on 31st March 2013.

Amendments to the Trade Marks (International Registration) Order 2008

- 2. The Trade Marks (International Registration) Order 2008(3) is amended as follows.
- **3.**—(1) Schedule 2 (which sets out modifications to provisions of the Trade Marks Act 1994 which apply to International Trade Marks (UK)) is amended as follows.
- (2) In paragraph 6 (which inserts section 38A into the Trade Marks Act 1994), in the text of section 38A(5) set out in that paragraph, for "beginning with" substitute "beginning immediately after".
- **4.** In Schedule 3, paragraphs 2(6) and 3(3), for "beginning with" substitute "beginning immediately after".

5. In Schedule 4, paragraph 1(4), for "beginning with" substitute "beginning immediately after".
