Amendments of the Friendly Societies Act 1974

 - (p) section 91(1A), (2), (3) and (5)**(16)** (cancellation and suspension of registration);
 - (q) section 94(4) and (7)**(17)** (instrument of dissolution);
 - (r) section 99(6)**(18)** (punishment of fraud, etc, and recovery of property misapplied);
