ROAD TRAFFIC

The A49 Trunk Road (Redhill, Herefordshire) (Temporary Prohibition of Traffic) Order 2014

Made - - - 22nd April 2014

Coming into force - - 29th April 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A49 Trunk Road ("the A49"), is satisfied that traffic on a length of that road, at Redhill in the County of Herefordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A49 Trunk Road (Redhill, Herefordshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Tuesday 29th April 2014.

2. In this Order:

"the trunk road" means the northbound and southbound carriageways of the

A49 between its junction with the A466 and its junction

with Red Hill Avenue;

"bus stop area" means any area of a carriageway on a side of the trunk

road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025, 1025.1, 1025.3 or 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

"the works period" means the period starting at 20:00 hours on Tuesday 6th

May 2014 and ending when the said works have been

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.

- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the bus stop area situated adjacent to the northbound carriageway of the A49 approximately 80 metres north of its junction with Walnut Tree Avenue.
- 5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or leave the northbound and southbound carriageways of the A49 at its junctions with
 - a) Mayberry Avenue;
 - b) Pencroft Road; or
 - c) Hinton Road.
- **6**. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - 7. The provisions of article 3, 4 and 5 shall not apply to any vehicle-
 - i. being used for police, fire brigade or ambulance purposes;
 - ii. proceeding at the direction of, or with the permission of, a police constable;
 - iii. being used in connection with the said works; or
 - iv. proceeding to and from premises which are accessible from, and only from, the trunk road.
