The Air Navigation (Restriction of Flying) (Overton) Regulations 2014

Made - - - - 10th June 2014

Coming into force - - 22nd August 2014

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Overton, Hampshire, by reason of flying displays that are scheduled to take place there between 22nd and 24th August 2014 as part of the Carfest South event.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Overton) Regulations 2014 and come into force on 22nd August 2014.

Interpretation

2. In regulation 3 all times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 1100 hours and 1600 hours on each day in the period beginning with 22nd August and ending on 24th August 2014, no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by a circle having a radius of 1.5 nautical miles whose centre is at 511325N 0011500W.
- (2) Paragraph (1) does not apply to any aircraft flying with the permission of the Carfest South flying display director.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace in the vicinity of Overton, Hampshire, on the occasion of air displays that are scheduled to take place there between 22nd and 24th August 2014 as part of Carfest South. A large number of civil and military aircraft will be involved in high-energy manoeuvres during the event. For reasons of public safety the Civil Aviation Authority and Department for Transport consider that flying should be restricted in the vicinity of Overton on the days when the air shows take place.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time.

In relation to the permission mentioned in regulation 3(2), the Carfest South flying display director may be contacted on telephone 07977 901711.

Full details of the airspace restrictions will be promulgated by Aeronautical Information Circular and NOTAM.
