ROAD TRAFFIC

The A43 Trunk Road (Silverstone, Northamptonshire) (Temporary Restriction of Traffic) Order 2014

 Made
 15th August 2014

 Coming into force
 22nd August 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A43 Trunk Road ("the A43") and connecting roads, is satisfied that traffic on a length of that road and some of those connecting roads, near Silverstone in the County of Northamptonshire, should be restricted because of the likelihood of danger to the public:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

- **1.** This Order may be cited as the A43 Trunk Road (Silverstone, Northamptonshire) (Temporary Restriction of Traffic) Order 2014 and shall come into force on Friday 22nd August 2014.
- **2.** Subject as mentioned in article 3 below, no person shall, during the period starting at 00.01 hours on Friday 29th August 2014 and ending when the said likelihood of danger has been avoided by means other than this order, drive any motor vehicle at a speed exceeding 50 miles per hour on
 - a) the northbound and southbound carriageways of the A43 between a point 1200 metres north
 of its junction with the slip road leading to the A413, northeast of Silverstone, and a point
 2700 metres south of its junction with the slip road leading from the A413 Dadford Road,
 southwest of Silverstone;
 - b) the slip road leading
 - i. from the northbound carriageway of the A43 to the A413 Brackley Road;
 - ii. to the northbound carriageway of the A43 from the A413 Dadford Road;
 - iii. to the northbound carriageway of the A43 from its roundabout junction with the A413 Towcester Road;
 - iv. from the southbound carriageway of the A43 to its roundabout junction with the A413 Towcester Road;
 - v. from the southbound carriageway of the A43 to Dadford Road; and

- vi. to the southbound carriageway of the A43 from Dadford Road.
- **3.** The provisions of article 2 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle
 - (a) being used for police, fire brigade, ambulance or special forces purposes; or
 - (b) proceeding at the direction of, or with the permission of, a police constable.
