ROAD TRAFFIC

The A63 Trunk Road (Priory Way Interchange to Brighton Street Interchange) (Temporary Prohibition of Traffic) Order 2014

Made - - - - *11th September 2014*

Coming into force - - *21st September 2014*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A63 Trunk Road and connecting roads, in the District of Kingston upon Hull, in the East Riding of Yorkshire, is satisfied that traffic on that trunk road and one of those connecting roads should be prohibited because carriageway resurfacing, road marking, pavement patching and general routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the A63 Trunk Road (Priory Way Interchange to Brighton Street Interchange) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 21st September 2014.

2. In this Order:-

“the A63” means the A63 Trunk Road;

“the eastbound carriageway” means the A63 eastbound carriageway from a point 240 metres west of the centre point of Priory Way Interchange overbridge to the eastbound entry slip road at Brighton Street Interchange, a distance of 4000 metres;

“a slip road” means the following A63 slip roads:

(i) eastbound entry and exit slip roads at Brighton Street Interchange; or

(ii) eastbound entry slip road at Priory Street Interchange;

“a layby” means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition “carriageway” means any way (other than a cycle track) comprised in the A63 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 22nd September 2014 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the eastbound carriageway or a slip road.

4. Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or wait in the layby situated adjacent to the A63 eastbound carriageway approximately 1500 metres east of Priory Way Interchange overbridge.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
