ROAD TRAFFIC

The A160 Trunk Road (Eastfield Road to Habrough Road Roundabout) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 28th August 2014

Coming into force - - 7th September 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A160 Trunk Road and connecting roads, in the County of North Lincolnshire, is satisfied that traffic on that trunk road and some of those connecting roads should be prohibited because pavement patching, gully repair, road marking, road stud and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the A160 Trunk Road (Eastfield Road to Habrough Road Roundabout) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 7th September 2014.

2. In this Order: -

"the A160" means the A160 Trunk Road;

"the carriageway" means the A160 westbound and eastbound carriageways from it junction with Eastfield Road to its junction with Habrough Road Roundabout, a distance of 1000 metres;

"a layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition "carriageway" means any way (other than a cycle track) comprised in the A160 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the first works period" means a period of 10 hours starting at 20:00 hours on Monday 8th September 2014 or any subsequent night thereafter until the said works have been completed;

"the second works period" mean a period starting at 00:01 hours on Monday 8th September 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 7 no person shall, during the first works period, cause or permit any vehicle to enter or proceed in the carriageway.

- **4.** Subject as mentioned in article 7 no person shall, during the second works period, cause or permit any vehicle to enter or wait in the layby situated adjacent to the A160 southbound carriageway 365 metres north of the A160/A180 at Brocklesby Interchange.
- **5.** Subject as mentioned in article 7, no person shall, during the first works period, cause or permit any vehicle to enter or proceed through the gaps in the central reservation between Habrough Road and Eastfield Road.
- **6.** Subject as mentioned in article 7, no person shall, during the first works period, cause or permit any vehicle to enter or leave the A160 eastbound or westbound carriageways at Town Street.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
