# The Motor Vehicles (Driving Licences) (Amendment) (No.2) Regulations 2014

Made	19th September 2014
Laid before Parliament	30th September 2014
Coming into force	31st October 2014

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 97(1), 99(7ZA) and 105(1) and (4) of the Road Traffic Act 1988(**a**) (the "1988 Act"), and by virtue of the Department for Transport (Driver Licensing and Vehicle Registration Fees) Order 2003(**b**) and, in accordance with section 105(4) of the 1988 Act, with the approval of the Treasury.

In accordance with section 195(2) of the 1988 Act the Secretary of State has consulted with representative organisations:

#### **Citation and commencement**

**1.**—(1) These Regulations may be cited as the Motor Vehicles (Driving Licences) (Amendment) (No.2) Regulations 2014.

(2) These Regulations come into force on 31st October 2014.

#### **Amendment of Regulations**

**2.** In the Motor Vehicles (Driving Licences) Regulations 1999(c) in Schedule 3 (licence fees) in Part 1 (table of fees applying on or after 1st April 2008) the table is amended as follows—

(a) for item number 1 substitute—

### EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend certain fees in the Motor Vehicles (Driving Licences) Regulations 1999. These Regulations also introduce lower fees for online applications for first licences and licence renewals to reflect the lower costs involved in processing online applications. Fee changes with the percentage decrease are shown in the table below.
