The Plant Health (*Phytophthora kernovii* Management Zone) (England) (Revocation) Order 2014

Made - - - - 17th October 2014

Laid before Parliament 30th October 2014

Coming into force - - 1st December 2014

The Secretary of State, in exercise of the powers conferred by sections 3(1), (2) and (4) and 4(1) of the Plant Health Act 1967(1) and now vested in the Secretary of State(2), and the Forestry Commissioners, in exercise of the powers conferred on them by those sections, make this Order.

Title and commencement

1. This Order may be cited as the Plant Health (*Phytophthora kernovii* Management Zone) (England) (Revocation) Order 2014 and comes into force on 1st December 2014.

Revocation

2. The Plant Health (*Phytophthora kernovii* Management Zone) (England) Order 2004(3) is revoked.
