Citation and interpretation

- 1. This Order may be cited as the Defence Reform Act 2014 (Commencement No. 3) Order 2014.
- 2. In this Order "the Act" means the Defence Reform Act 2014.

Commencement

- 3. The following provisions of the Act come into force on 5 December 2014—
 - (a) sections 14 to 18;
 - (b) section 19(2), (3), (5) and (6);
 - (c) sections 20 to 36;
 - (d) sections 38 and 39;
 - (e) section 43;
 - (f) paragraph 10(2) to (6) of Schedule 4;
 - (g) Schedule 5, with the exception of paragraph 2(5) and paragraph 6(4).
