The Access to the Countryside (Coastal Margin) (Filey Brigg to Newport Bridge) Order 2016

Made - - - - 20th June 2016

Coming into force in accordance with article 1(1)

The Secretary of State makes this Order in exercise of the powers conferred by section 3A(10) of the Countryside and Rights of Way Act 2000(a).

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Access to the Countryside (Coastal Margin) (Filey Brigg to Newport Bridge) Order 2016, and comes into force on the day after the day on which it is made.
- (2) In this Order, "the Act" means the National Parks and Access to the Countryside Act 1949(**b**).

End of access preparation period

- **2.**—(1) In relation to land which is coastal margin as a result of the relevant approval, the day appointed as the day on which the access preparation $period(\mathbf{c})$ ends is 20th July 2016.
 - (2) In this article—

"the relevant approval" means the approval by the Secretary of $State(\mathbf{d})$ under section 52(1) of the $Act(\mathbf{e})$ of the relevant report on 22nd December 2015;

The Minister of Town and Country Planning was renamed the Minister of Local Government and Planning by the Transfer of Functions (Minister of Health and Minister of Local Government and Planning) (No. 1) Order 1951 (S.I. 1951/142), and was further renamed the Minister of Housing and Local Government by the Minister of Local Government and Planning (Change of Style and Title) Order 1951 (S.I. 1951/1900). The Minister of Land and Natural Resources Order 1965 (S.I. 1965/143) transferred (so far as relevant) the functions of the Minister of Housing and Local Government to the Minister of Land and Natural Resources. The Ministry of Land and Natural Resources was dissolved by the Ministry of Land and Natural Resources (Dissolution) Order 1967 (S.I. 1967/156) and the functions of that Minister (so far as relevant) were transferred to the Minister of Housing and Local Government. The Ministry of Housing and Local Government was dissolved, and the functions of that Minister were transferred to the Secretary of State, by the Secretary of State for the Environment Order 1970 (S.I. 1970/1681).

This Order appoints the day on which the access preparation period ends in relation to land which is coastal margin as a result of the approval by the Secretary of State of Natural England's proposals contained in a report relating to coastal access along the long-distance route in North Yorkshire and Teesside from Filey Brigg to Newport Bridge.
