

**TRANSPOSITION NOTE TO
THE ROAD VEHICLES (REGISTRATION AND LICENSING) (AMENDMENT) REGULATIONS
2017 – S.I. No. 2017/554.**

The S.I. transposes EU Directive 2015/413 of the European Parliament and of the Council of 11th March 2015 facilitating cross-border exchange of information on road safety related traffic offences.

| Annex 1 | Data elements necessary to conduct searches pursuant to Article 4(1) and data to be provided in response to searches pursuant to Article 4(1). | Regulation 3 |
