#### General

## Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Ministry of Defence Police (Conduct and Appeals Tribunals) (Amendment) Regulations 2018 and come into force on 1st December 2018.
  - (2) In these Regulations—
    - "the 1987 Act" means the Ministry of Defence Police Act 1987;
    - "the 2009 Regulations" means the Ministry of Defence Police Appeals Tribunals Regulations 2009 MI;
    - "the Conduct Regulations" means the Ministry of Defence Police (Conduct etc.) Regulations 2015 M2.
