EXPLANATORY MEMORANDUM TO

THE NORTHERN IRELAND (EXTENSION OF PERIOD FOR EXECUTIVE FORMATION) REGULATIONS 2019

2019 No. 616

1. Introduction

- 1.1 This explanatory memorandum has been prepared by the Northern Ireland Office and is laid before Parliament by Command of Her Majesty.
- 1.2 This memorandum contains information for the Joint Committee on Statutory Instruments.

2. Purpose of the instrument

- 2.1 The purpose of this instrument is to extend the period set out in the Northern Ireland (Executive Formation and Exercise of Functions) Act 2018 ("the 2018 Act") in which Northern Ireland Ministers can be appointed following the Northern Ireland Assembly election on 2 March 2017 ("the period for Executive formation") from 26 March 2019 to 25 August 2019.
- 2.2 Once the period for Executive formation ends, the Secretary of State will be required to propose a date for an Assembly election. The effect of extending this period, therefore, is that the Secretary of State will not fall under that duty until after 25 August 2019. Northern Ireland departments will also continue to exercise their functions in accordance with section 3 of the 2018 Act until then.

3. Matters of special interest to Parliament

Matters of special interest to the Joint Committee on Statutory Instruments

- 3.1 This instrument will come into force on 25 March 2019 which will be less than 21 days after it is made. The powers to extend the period for Executive formation can only be exercised before that period expires, therefore the instrument must be made and come into force before 26 March 2019. However, the instrument does not diminish the legal rights of persons affected, impose new duties on such persons or require them to adopt different patterns of behaviour.
- 3.2 The Secretary of State has not made the Regulations before now as she has been engaging with the Northern Ireland political parties and the Irish Government on the resumption of talks to enable an Executive to be formed. She considered that preemptively making Regulations to extend the period for Executive formation could compromise that process and be prejudicial to the discussions. It is also for that reason that she considered it to be expedient for the Regulations to be made without the prior approval of both Houses of Parliament.

Matters relevant to Standing Orders Nos. 83P and 83T of the Standing Orders of the House of Commons relating to Public Business (English Votes for English Laws)

- 3.3 The territorial application of this instrument is limited to Northern Ireland.
- 3.4 This instrument enables an Executive to be formed in Northern Ireland until 25 August 2019; it has no application elsewhere in the United Kingdom.

4. Extent and Territorial Application

- 4.1 The territorial extent of this instrument is the whole of the United Kingdom.
- 4.2 The territorial application of this instrument is Northern Ireland.

5. European Convention on Human Rights

5.1 The Secretary of State for Northern Ireland, Karen Bradley MP, has made the following statement regarding Human Rights:

"In my view the provisions of the Northern Ireland (Extension of Period for Executive Formation) Regulations 2019 are compatible with the Convention rights"

6. Legislative Context

6.1 Section 1 of the 2018 Act retrospectively extended the period for Executive formation following the Assembly election on 2 March 2017 so as to expire on 26 March 2019. It had previously been extended so as to expire on 29 June 2017 by the Northern Ireland (Ministerial Appointments and Regional Rates) Act 2017. Section 2(1) of the 2018 Act enables the Secretary of State, by regulations, to extend the period for Executive formation for one further period of up to five months. That power may only be exercised on or before 26 March 2019 and may only be used once (see section 2(2) of the 2018 Act).

7. Policy background

What is being done and why?

- 7.1 There has been no functioning Northern Ireland Executive since 9 January 2017, when the then deputy First Minister of Northern Ireland resigned, which also resulted in the First Minister ceasing to hold office. All other Northern Ireland Ministers ceased to hold office when an extraordinary Assembly election was held on 2 March 2017. The period for Executive formation was extended to 29 June 2017 by the Northern Ireland (Ministerial Appointments and Regional Rates) Act 2017, but no Ministers were appointed.
- 7.2 The 2018 Act retrospectively extended the period for Executive formation until 26 March 2019. This was to facilitate the appointment of Ministers without the need for further legislation and to enable talks to take place. Ministers have not yet been appointed and the Secretary of State for Northern Ireland has taken the view that further time is necessary for this, such that the period for Executive formation should be extended by the maximum period of 5 months provided for by that Act. This means the period will end on 25 August 2019.
- 7.3 As described in paragraph 2.2 above, extending the period for Executive formation until 25 August 2019 also means that the Secretary of State will not fall under a duty to propose a date for an Assembly election until after that date. It also means that, during this extended period, senior officers in Northern Ireland departments will continue to exercise departmental functions in the absence of Northern Ireland Ministers in accordance with section 3 of the 2018 Act.

8. European Union (Withdrawal) Act/Withdrawal of the United Kingdom from the European Union

8.1 This instrument does not relate to withdrawal from the European Union.

9. Consolidation

9.1 This instrument does not consolidate previous instruments.

10. Consultation outcome

10.1 The Northern Ireland Office has discussed the instrument with the main Northern Ireland political parties.

11. Guidance

11.1 The Northern Ireland Office does not consider it necessary to issue any guidance specifically in relation to this instrument.

12. Impact

- 12.1 There is no, or no significant, impact on business, charities or voluntary bodies.
- 12.2 There is no, or no significant, impact on the public sector.
- 12.3 An Impact Assessment has not been prepared for this instrument because there is no, or no significant, impact on business, charities, voluntary bodies or the public sector.

13. Regulating small business

13.1 The legislation does not apply to activities that are undertaken by small businesses.

14. Monitoring & review

14.1 The Secretary of State for Northern Ireland will continue to monitor the political situation in Northern Ireland and will continue to make decisions necessary for the good governance of Northern Ireland in the absence of an Executive. The period for Executive formation as extended by this instrument is time limited and will end on 25 August 2019.
