Chapter 1

Amendment of primary legislation

Amendment of the Immigration and Asylum Act 1999

11.—(1) The Immigration and Asylum Act 1999 ^{M1} is amended as follows.

(3) In section 24 (duty to report suspicious marriages) ^{M2}, in subsection (6)—

(a) in the definition of “relevant national”, in paragraph (b), omit “other than the United Kingdom”;

(b) omit the definition of “United Kingdom immigration law”.

(4) In section 24A (duty to report suspicious civil partnerships) ^{M3}, in subsection (5A)—

(a) in the definition of “relevant national”, in paragraph (b), omit “other than the United Kingdom”;

(b) omit the definition of “United Kingdom immigration law”.

(6) In section 84 (provision of immigration services) ^{M4}, in subsection (2)—

(a) omit paragraphs (c) and (d) (but not the “or” at the end of paragraph (d));

(b) in paragraph (e), for “(d)” substitute “(ba)”.

(7) In section 86 (designated professional bodies) ^{M5}, in subsection (8), in paragraph (a), for “an EEA State” substitute “Scotland or Northern Ireland”.

(8) In section 93 (disclosure of information) ^{M6}, in subsection (3)(b), omit “or any EU obligation of the Commissioner”.
