

The Export Control (Amendment) Order 2019

Transposition Note

This Transposition Note, in tabular form, explains how the Export Control (Amendment) Order 2019 (“the 2019 Order”) transposes (EU) Directive 2019/514 (“the 2019 Directive”) amending Directive 2009/43/EC of the European Parliament and of the Council of 6 May 2009 (“the ICT Directive”). The ICT Directive, as amended, is implemented in the UK by the Export Control Order 2008 (“the 2008 Order”).

The 2019 Directive substitutes a new Annex to the ICT Directive and, to the extent that the new Annex differs from its predecessor, provisions in the 2019 Order amend Schedule 2 to the 2008 Order to reflect the differences.
