**The Power to Award Degrees etc. (Dyson

The Office for Students, in exercise of the powers conferred by section 42(1) of the Higher Education and Research Act 2017⁽¹⁾, makes the following Order:

Citation and commencement

1. This Order may be cited as the Power to Award Degrees etc. (Dyson Technical Training Limited) Order 2020 and shall come into force on 1st September 2021.

Competence to grant awards

[^{F1}2. Dyson Technical Training Limited shall be competent to grant the following specified taught awards of the kind mentioned in section 42(2)(b) of the said Act:

- (a) BEng in Engineering;
- (b) BEng (Hons) in Engineering;
- (c) BEng (Hons) in Engineering Degree Apprenticeship;
- (d) CertHE in Engineering; and
- (e) DipHE in Engineering.]

3. Dyson Technical Training Limited shall only be competent to grant the specified taught awards mentioned in [^{F2}article] 2 of this Order for a fixed term beginning on 1st September 2021 and expiring on 30th November 2024.
