## Appointed day, saving and transitional provisions – Taxation (Cross-border Trade) Act 2018

- **4.** The day appointed for the coming into force of the following provisions of the Taxation (Crossborder Trade) Act 2018, so far as not already in force, is IP completion day—
  - (a) Part 1 (import duty), other than paragraph 90 of Schedule 7;
  - (b) Part 3 (value added tax);
  - (c) Part 4 (excise duties).
