**The A47 North Tuddenham to Easton Development Consent
(Correction) Order 2023**

Made - - - - *10th October 2023*

Coming into force *11th October 2023*

The A47 North Tuddenham to Easton Development Consent Order 2022 (“the 2022 Order”)(a), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(b), contained correctable errors as defined in paragraph 1(3) of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(c) for the correction of errors in the 2022 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed the relevant local planning authorities for the area in which the land to which the 2022 Order relates is situated, that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and (8) of Schedule 4 to, the Act, makes the following Order.

Citation and commencement

1. This Order may be cited as the A47 North Tuddenham to Easton Development Consent (Correction) Order 2023 and comes into force on 11th October 2023.

2. The 2022 Order is corrected as set out in the table in the Schedule to this Order, where—
- (a) column 1 sets out where the correction is to be made;
 - (b) column 2 sets out how the correction is to be made; and
 - (c) column 3 sets out the text to be substituted, inserted or omitted.
