    - [F3·(3A)] In the application of this section in England and Wales, the reference in subsection (3)(b) to 12 months is to be read as a reference to the general limit in a magistrates' court (or to 6 months in relation to an offence committed before 2 May 2022)."
  - (b) Omit subsection (6)(a).
