The Air Navigation (Restriction of Flying) (Royal Air Force Odiham) Regulations 2023

Made - - - - *19th July 2023*

Coming into force - - *18th August 2023*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the area specified in regulation 3(1) by reason of the intended holding of flying displays at Royal Air Force Odiham.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Royal Air Force Odiham) Regulations 2023 and they come into force on 18th August 2023.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1100 hours and 1700 hours on 18th August 2023 no aircraft is to fly below 4,000 feet above mean sea level within the area bounded by a circle having a radius of 3 nautical miles centred at 511403N 0005634W.

(2) Paragraph (1) does not apply to any aircraft—

- (a) flying in accordance with a permission issued by the Royal Air Force Odiham Air Show flying display director, or
- (b) operating under the direction of the air traffic control unit at Royal Air Force Odiham.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Royal Air Force Odiham, Hampshire during air displays that are due to take place there on 18th August 2023.

Many aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2)(a), the Royal Air Force Odiham Air Show flying display director may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Briefing Sheet and Notice to Aviation (NOTAM).
