The A47 Blofield to North Burlingham Development Consent (Correction) Order 2023

Made - - - - 28th July 2023

Coming into force - - 31st July 2023

The A47 Blofield to North Burlingham Development Consent Order 2022 ("the Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contains correctable errors as defined in paragraph 1(3) of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(\mathbf{c}) for the correction of errors and omissions in the Order, and issued a statement that the Secretary of State was considering making corrections under paragraph (1)(5)(b) of Schedule 4 to the Act.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed the relevant local planning authorities for the area in which the land to which the Order relates is situated, that the request has been received in accordance with paragraph 1(7) of Schedule 4 to the Act.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraph 1(4) and (8) of Schedule 4 to, the Act, makes the following Order:

Citation and commencement

1. This Order may be cited as the A47 Blofield to North Burlingham Development Consent (Correction) Order 2023 and comes into force on 31st July 2023.
