Mae'r Gorchymyn hwn yn diwygio'r Gorchymyn a sefydlodd Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Bro Morgannwg i newid y dibenion y sefydlwyd yr ymddiriedolaeth er eu mwyn ac i ddiwygio'i swyddogaethau.

This Order amends the Order which established the Bro Morgannwg National Health Service Trust to alter the purposes for which the trust has been established and to amend its functions.

Mae'r Gorchymyn yn rhoi i'r ymddiriedolaeth ddibenion darparu nwyddau a gwasanaethau at ddibenion y gwasanaeth iechyd fel y'u pennir yn adran 5(1) o Ddeddf y Gwasanaeth Iechyd Gwladol a Gofal Cymunedol 1990 ac, yn unol â'r dibenion hynny, yn estyn swyddogaethau'r ymddiriedolaeth i gynnwys swyddogaeth darparu nwyddau a gwasanaethau (gan gynnwys cyfleusterau ysbyty a gwasanaethau iechyd cymunedol) yn yr ysbytai a ddisgrifir neu ohonynt. Mae'r Gorchymyn yn cynnwys darpariaeth mewn perthynas â throsglwyddo pob gwasanaeth o Ysbyty Cyffredinol Castell-nedd a'i gau ac mewn perthynas â darparu'r gwasanaethau hynny sydd i'w darparu mewn ysbyty newydd yn Ffordd Baglan, Port Talbot. Bu'r trefniadau hynny yn destun ymgynghoriad cyhoeddus, gan gynnwys ymgynghoriad â'r Cyngor Iechyd Cymunedol perthnasol.

The Order confers on the trust the purposes of providing goods and services for the purposes of the health service as specified in section 5(1) of the National Health Service and Community Care Act 1990 and, in pursuance of those purposes, extends the functions of the trust to include the function of providing goods and services (including hospital facilities and community health services) at or from the hospitals described. The Order includes provision in relation to the transfer of all services from Neath General Hospital and its closure and in relation to the provision of such services to be provided at a new hospital at Baglan Way, Port Talbot. Such arrangements have been the subject of public consultation including consultation with the relevant Community Health Council.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 126(3) a (4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(a) ac adran 5(1) o Ddeddf y Gwasanaeth Iechyd Gwladol a Gofal Cymunedol 1990(b) a pharagraffau 1 a 3 o Atodlen 2 iddi ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru(c) drwy hyn yn gwneud y Gorchymyn canlynol:

The National Assembly for Wales, in exercise of the powers conferred on the Secretary of State by sections 126(3) and (4) of the National Health Service Act 1977(a) and section 5(1) of, and paragraphs 1 and 3 of Schedule 2 to the National Health Service and Community Care Act 1990(b) and now vested in the National Assembly for Wales(c) hereby makes the following Order:

Citation, commencement and application

1.-(1) This Order may be cited as the Bro Morgannwg National Health Service Trust (Establishment) Amendment Order 2000 and shall come into force on 7th April 2000.

(2) This Order applies to Wales only.

2. For article 3 of the Bro Morgannwg National Health Service Trust (Establishment) Order 1998(d) there shall be substituted the following article:-
