**The Education (National Curriculum)  
(Attainment Targets and Programmes of Study  
in Physical Education) (Wales) Order 2000**

*Made - - - - 10th April 2000*  
*Coming into force except as 1st August 2000*  
*provided in article 1(2)*

The requirements set out in the Schedule have been fulfilled.

In exercise of the powers conferred on the Secretary of State by section 356 (2) (a) and (b) and (4) of the Education Act 1996<sup>(1)</sup> and now vested in the National Assembly for Wales<sup>(2)</sup>, the National Assembly for Wales makes the following Order:

**Citation, commencement, interpretation and application**

1.—(1) This Order may be cited as the Education (National Curriculum) (Attainment Targets and Programmes of Study in Physical Education) (Wales) Order 2000 and, subject to paragraph (2) below, shall come into force on 1st August 2000.

(2) The provisions of this Order insofar as they relate to the fourth key stage shall come into force—

- (a) on 1st August 2001 in respect of pupils in the first year of that key stage: and
- (b) on 1st August 2002 in respect of all other pupils in that key stage.

(3) In this Order—

“the Authority” means the Qualifications, Curriculum and Assessment Authority for Wales<sup>(3)</sup> (“yr Awdurdod”);

“the Document” means the document published by the Authority in 2000 entitled “Physical Education in the National Curriculum”<sup>(4)</sup> (“y Ddogfen”);

references to key stages shall be construed in accordance with section 355(1) of the Education Act 1996.

#### Revocation

2. The Education (National Curriculum) (Attainment Targets and Programmes of Study in Physical Education) (Wales) Order 1998(5) shall cease to apply—

- (a) on 1st August 2000 in respect of pupils in the first, second and third key stages;
- (b) on 1st August 2001 in respect of pupils in the first year of the fourth key stage; and

shall be revoked on 1st August 2002.

3. The National Assembly directs that the provisions relating to attainment targets and programmes of study set out in the Document shall have effect for the purpose of specifying the attainment targets and programmes of study in relation to physical education.

4. The examples printed in italics in the Document (which serve to illustrate the programmes of study described therein) do not form part of the provision made by this Order.

The National Curriculum for Wales for physical education will be revised from 1st August 2000. This Order gives legal effect to the new programmes of study, which set out what pupils should be taught, and attainment targets for them. Details of these are set out in a document called “Physical
