EDUCATION, WALES

The Education (National Curriculum) (Attainment Targets and Programmes of Study in Geography) (Wales) Order 2000

Made - - - - *10th April 2000*
Coming into force - - *1st August 2000*

The requirements set out in the Schedule have been fulfilled.

In exercise of the powers conferred on the Secretary of State by section 356(2)(a) and (b) and (4) of the Education Act 1996⁽¹⁾ and now vested in the National Assembly for Wales⁽²⁾, the National Assembly for Wales makes the following Order:

PROSPECTIVE

Citation, commencement, interpretation and application

1.—(1) This Order may be cited as the Education (National Curriculum) (Attainment Targets and Programmes of Study in Geography) (Wales) Order 2000 and shall come into force on 1st August 2000.

(2) In this Order—

“the Authority” means the Qualifications, Curriculum and Assessment Authority for Wales⁽³⁾ (“*yr Awdurdod*”);

“the Document” means the document published by the Authority in 2000 entitled “Geography in the National Curriculum”⁽⁴⁾ (“*y Ddogfen*”);

“the National Assembly” means the National Assembly for Wales (“*y Cynulliad Cenedlaethol*”).

(3) This Order applies only to schools in Wales.
