The Education (National Curriculum) (Attainment Targets and Programmes of Study in Modern Foreign Languages) (Wales) Order 2000

Made - - - - 10th April 2000

Coming into force - - 1st August 2000

The requirements set out in the Schedule have been fulfilled.

In exercise of the powers conferred on the Secretary of State by section 356(2)(a) and (b) and (4) of the Education Act 1996⁽¹⁾ and now vested in the National Assembly for Wales⁽²⁾, the National Assembly for Wales makes the following Order:

PROSPECTIVE

Citation, commencement, interpretation and application

1.—(1) This Order may be cited as the Education (National Curriculum) (Attainment Targets and Programmes of Study in Modern Foreign Languages) (Wales) Order 2000 and shall come into force on 1st August 2000.

(2) In this Order—

“the Authority” means the Qualifications, Curriculum and Assessment Authority for Wales⁽³⁾ (“*yr Awdurdod*”);

“the Document” means the document published by the Authority in 2000 entitled “Modern Foreign Language in the National Curriculum”⁽⁴⁾ (“*y Ddogfen*”);

“the National Assembly” means the National Assembly for Wales (“*y Cynulliad Cenedlaethol*”).

(3) This Order applies only in relation to schools in Wales.

(2) The functions of the Secretary of State under section 356 of the Education Act 1996 were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I.1999/672).

(3) The Qualifications, Curriculum and Assessment Authority for Wales was established by section 14(1)(b) of the Education Reform Act 1988 (c. 40), continued in existence by section 360 of the Education Act 1996 and given its current name by section 27(1) of the Education Act 1997.
