Mae'r Gorchymyn hwn yn dwyn i rym, mewn perthynas â Chymru yn unig, y darpariaethau hynny yn Rhan I o Ddeddf Llywodraeth Leol Cymru 2000 nad ydynt mewn grym hyd yn hyn a diddymiadau canlyniadol o amryw o ddarpariaethau statudol.

This Order brings into force on 9th April 2001, in relation to Wales only, those provisions of Part I of the Local Government Act 2000 which are not yet in force and consequential repeals of various statutory provisions.

Part I of the Act is concerned with the promotion by local authorities of the economic, social and environmental well-being of their areas.
