Mae Erthygl 16 o Reoliad y Cyngor (CE) Rhif 2037/2000 ar sylweddau sy'n disbyddu'r haen osôn yn ei gwneud yn ofynnol i adennill sylweddau rheoledig sydd wedi'u defnyddio (fel y'u diffiniwyd yn Erthygl 2 o'r Rheoliad) sydd mewn cyfarpar rheweiddiad gwastraff, neu gyfarpar arall.

Article 16 of Council Regulation (EC) No. 2037/2000 on substances that deplete the ozone layer requires the recovery of used controlled substances (as defined in Article 2 of the Regulation) in waste refrigeration and other equipment.

Mae Rheoliad 12 o Reoliadau Trwyddedu Rheoli Gwastraff 1994 yn darparu bod rhai mathau o offer yn gallu cael eu trin fel offer symudol at ddibenion Rhan II o Ddeddf Diogelu'r Amgylchedd 1990.

Regulation 12 of the Waste Management Licensing Regulations 1994 provides for certain descriptions of plant to be treated as mobile plant for the purposes of Part II of the Environmental Protection Act 1990.

Mae'r Rheoliadau hyn yn diwygio rheoliad 12, mewn perthynas â Chymru, drwy ychwanegu math o offer ar gyfer casglu a storio sylwedd rheoledig o eitemau sy'n wastraff. Bydd hyn yn galluogi Asiantaeth yr Amgylchedd i awdurdodi offer symudol ar gyfer adennill sylweddau sy'n disbyddu osôn o gyfarpar rheweiddiad sy'n wastraff, diffoddiaduron tân ac eitemau eraill.

These Regulations amend regulation 12, in relation to Wales, by adding a description of plant for the collection or storage of a controlled substance from waste items. This enables the Environment Agency to authorise mobile plant for the recovery of ozone depleting substances from waste refrigeration equipment, fire extinguishers and other items.

1. -(1) These Regulations may be cited as the Waste Management Licensing (Amendment) (Wales) Regulations 2002 and come into force on the 16th April 2002.

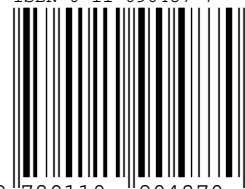
