Mae'r Gorchymyn hwn yn diwygio Gorchymyn Iechyd Planhigion (Prydain Fawr) 1993 ("y prif Orchymyn") er mwyn gweithredu elfennau penodol o Gyfarwyddbau'r Comisiwn 2002/29/EC (OJ Rhif L77, 20.3.02, t. 26) a 2002/28/EC (OJ Rhif L77, 20.3.02, t. 23) yng Nghymru nad ydynt yn cael eu gweithredu mewn deddfwriaeth arall. Mae Cyfarwydddeb 2002/29/EC yn diwygio'r parthau gwarchod a sefydlwyd o dan Gyfarwydddeb y Cyngor 2000/29/EC (OJ Rhif L169, 10.7.2000, t.1) ("y brif Gyfarwydddeb Iechyd Planhigion") ac a amserlennwyd yn yr Atodiad i Gyfarwydddeb y Comisiwn 2001/32/EC (OJ Rhif. L127, 9.5.2001, t. 38). Mae Cyfarwydddeb 2002/28/EC yn darparu ar gyfer diwygiadau canlyniadol i Atodiadau penodol o'r brif Gyfarwydddeb Iechyd Planhigion.

This Order amends the Plant Health (Great Britain) Order 1993 ("the principal Order") so as to implement certain elements of Commission Directives 2002/29/EC (OJ No. L77, 20.3.02, p.26) and 2002/28/EC (OJ No. L77, 20.3.02, p.23) in Wales which are not implemented in other legislation. Directive 2002/29/EC amends the protected zones established under Council Directive 2000/29/EC (OJ No. L169, 10.7.2000, p.1) ("the principal Plant Health Directive") and scheduled in the Annex to Commission Directive 2001/32/EC (OJ No. L127, 9.5.2001, p. 38). Directive 2002/28/EC provides for consequential amendments to certain Annexes of the principal Plant Health Directive.

Mae'r diwygiadau yn y Gorchymyn hwn sy'n gweithredu Cyfarwydddeb 2002/28/EC yn erthygl 2(3) i 2(6) yn gynhwysol. Gweithredir Cyfarwydddeb 2002/29/EC gan erthygl 2(7), sy'n diwygio Atodlen 8 i'r prif Orchymyn. Y prif newidiadau i'r parthau gwarchod yw tynnu Prydain Fawr o'r parth gwarchod mewn perthynas â *Feirws necrotig gwythien felen betys* (sy'n hysbys fel rhizomania) (erthygl 2(3), (6)(a) a (c) a (7)(b)(i)), ac aildiffiniad o barthau gwarchod yr Eidal ac Awstria mewn perthynas â'r bacteriwm *Erwinia amylovora* (Burr.) Winsl. et al (sy'n hysbys fel malltod) (erthygl 2(4), (5), (6)(b) a (7)(a)). Diwygir y disgrifiad o *Citrus tristeza virus* yn Atodlen 8 (erthygl 2(7)(b)(ii)).

The amendments in this Order implementing Directive 2002/28/EC are at article 2(3) to 2(6) inclusive. Directive 2002/29/EC is implemented by article 2(7), which amends Schedule 8 to the principal Order. The principal changes to the protected zones are removal of Great Britain from the protected zone in respect of *Beet necrotic yellow vein virus* (known as rhizomania) (article 2(3), (6)(a) and (c) and (7)(b)(i)), and re-definition of the Italian and Austrian protected zones in respect of the bacterium *Erwinia amylovora* (Burr.) Winsl. et al (known as fireblight) (article 2(4), (5), (6)(b) and (7)(a)). An amendment is made to the description of *Citrus tristeza virus* in Schedule 8 (article 2(7)(b)(ii)).

Title, application and commencement

1. This Order may be cited as the Plant Health (Amendment) (Wales) Order 2002, it applies to Wales, and comes into force on 6th August 2002.

2.-(1) The Plant Health (Great Britain) Order 1993(d) shall be amended in accordance with paragraphs (2) to (7) below.
