## RATING AND VALUATION, WALES

The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2002

Made - - - - 10th December 2002

Coming into force - - 31st December 2002

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by sections 140(4) and 143(1) and (2) of, and paragraphs 4, 5 and 6 of Schedule 8 to, the Local Government Finance Act 1988(1), which are now vested in the National Assembly for Wales so far as exercisable in Wales(2):

#### Name, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2002 and shall come into force on 31st December 2002.
- (2) In these Regulations "the 1992 Regulations" means the Non-Domestic Rating Contributions (Wales) Regulations 1992(3).

## Amendment of the 1992 Regulations

- **2.** In relation to financial years beginning on or after 1st April 2003, Schedules 2 and 4 to the 1992 Regulations are amended as follows:—
  - (a) in paragraph 2(12) of Schedule 2 for "0.995" there is substituted "0.999"; and
  - (b) for Schedule 4 to the 1992 Regulations there is substituted the Schedule set out in the Schedule to these Regulations.

for Wales. Rules for the calculation of those amounts are contained in the Non-Domestic Rating Contributions (Wales) Regulations 1992.

These Regulations amend the 1992 Regulations by substituting a new multiplier in paragraph 2(12) of Schedule 2 (assumptions as to gross amount) and a new Schedule 4 (adult population figures).
