Mae paragraff 14(1) o Atodlen 9 i Ddeddf Llywodraeth Cymru 1998 yn darparu mai'r cyrff sy'n ddarostyngedig i ymchwiliad gan Ombwdsmon Gweinyddiaeth Cymru (yr Ombwdsmon) yw Cynulliad Cenedlaethol Cymru (y Cynulliad) a'r cyrff a restrir ym mharagraff 14(2) o'r Atodlen honno.

Paragraph 14(1) of Schedule 9 to the Government of Wales Act 1998 provides that the bodies that are subject to investigation by the Welsh Administration Ombudsman (the Ombudsman) are the National Assembly for Wales (the Assembly) and the bodies listed in paragraph 14(2) of that Schedule.

Mae paragraff 14(3) o'r Atodlen honno yn darparu y gall y Cynulliad drwy orchymyn ddiwygio paragraff 14(2) drwy ychwanegu neu ddileu unrhyw gorff neu drwy newid disgrifiad unrhyw gorff.

Paragraph 14(3) of that Schedule provides that the Assembly may by order amend paragraph 14(2) by adding or deleting any body or by altering the description of any body.

Mae'r Gorchymyn hwn yn ychwanegu Cyngor Cenedlaethol Cymru dros Addysg a Hyfforddiant (gweler Rhan 2 o Ddeddf Dysgu a Medrau 2000 mewn perthynas ag ef) a Chyngor Cyllido Addysg Uwch Cymru (gweler Rhan 2 o Ddeddf Addysg Bellach ac Uwch 1992 mewn perthynas ag ef) at y cyrff a restrir yn y paragraff 14(2) a enwyd.

This Order adds the National Council for Education and Training for Wales (in respect of which see Part 2 of the Learning and Skills Act 2000) and the Higher Education Funding Council for Wales (in respect of which see Part 2 of the Further and Higher Education Act 1992) to the bodies listed in the said paragraph 14(2).

Mae paragraff 15(1) o'r Atodlen honno yn cynnwys nodiadau sy'n cyfyngu ar gwmpas swyddogaethau ymchwilio yr Ombwdsmon mewn perthynas â rhai o'r cyrff y cyfeirir atynt ym mharagraff 14(2) neu'r cyfan ohonynt.

Paragraph 15(1) of that Schedule contains notes that limit the extent of the Ombudsman's investigatory functions in respect of some or all of the bodies referred to in paragraph 14(2).

Mae paragraff 15(2) yn darparu y gall y Cynulliad drwy orchymyn ddiwygio paragraff 15(1) drwy ychwanegu, hepgor neu ddiwygio unrhyw nodyn.

Paragraph 15(2) provides that the Assembly may by order amend paragraph 15(1) by adding, omitting or amending any note.

Mae'r Gorchymyn hwn yn ychwanegu Nodyn i baragraff 15(1). Mae'r Nodyn hwnnw yn darparu na all yr Ombwdsmon ymchwilio i unrhyw gŵyn yn erbyn

This Order adds a Note to paragraph 15(1). That Note provides that the Ombudsman may not investigate any complaint against the National Council

Cyngor Cenedlaethol Cymru dros Addysg a Hyfforddiant pan fo'r gŵyn yn ymwneud â gweithred a gymerwyd yn wreiddiol gan Gyngor Cyllido Addysg Bellach Cymru ac sydd ond yn cael ei thrin fel pe bai wedi'i chymryd gan Gyngor Cenedlaethol Cymru dros Addysg a Hyfforddiant drwy rinwedd paragraff 11 neu 12 o Atodlen 10 i Ddeddf Dysgu a Medrau 2000.

for Education and Training for Wales where the complaint relates to action originally taken by the Further Education Funding Council for Wales and which is only treated as having been taken by the National Council for Education and Training for Wales by virtue of paragraph 11 or 12 of Schedule 10 to the Learning and Skills Act 2000.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol, drwy arfer y pwerau a roddwyd iddo gan baragraffau 14(3) a 15(2) o Atodlen 9 i Ddeddf Llywodraeth Cymru 1998(a):

1. Enw'r gorchymyn hwn yw Gorchymyn Ombwdsmon Gweinyddiaeth Cymru (Awdurdodaeth) 2002 a daw i rym ar 31 Rhagfyr 2002.

2. Bydd gan Atodlen 9 i Ddeddf Llywodraeth Cymru 1998 effaith yn ddarostyngedig i'r diwygiadau canlynol:

- (a) Ym mharagraff 14(2) o'r Atodlen a enwyd ar ôl "the Forestry Commissioners," mewnosodir -
 - "(da) the Higher Education Funding Council for Wales,
 - (db) the National Council for Education and Training for Wales,"
- (b) Ym mharagraff 15(1) o'r Atodlen a enwyd, ar ôl nodyn 2 ychwanegir -

"2A. In the case of the National Council for Education and Training for Wales no investigation may be conducted by the Welsh Administration Ombudsman in respect of action taken by virtue of paragraph 11 or 12 of Schedule 10 to the Learning and Skills Act 2000."(b).

The National Assembly for Wales makes the following Order, in exercise of the powers conferred upon it by paragraphs 14(3) and 15(2) of Schedule 9 to the Government of Wales Act 1998(a):

1. This Order may be cited as the Welsh Administration Ombudsman (Jurisdiction) Order 2002 and shall come into force on 31st December 2002.

2. Schedule 9 to the Government of Wales Act 1998 shall have effect subject to the following amendments:

- (a) In paragraph 14(2) of the said Schedule after "the Forestry Commissioners," insert -
 - "(da) the Higher Education Funding Council for Wales,
 - (db) the National Council for Education and Training for Wales,"
- (b) In paragraph 15(1) of the said Schedule, after note 2 add -

"2A. In the case of the National Council for Education and Training for Wales no investigation may be conducted by the Welsh Administration Ombudsman in respect of action taken by virtue of paragraph 11 or 12 of Schedule 10 to the Learning and Skills Act 2000."(b).
