Mae'r Rheoliadau hyn yn darparu ar gyfer cynnydd o £15.50 i £20 yn y ffi sy'n daladwy gan ymgymerywr am archwiliadau o'u gwaith gan awdurdodau lleol yng Nghymru o dan reoliad 3(1) o Reoliadau Gweithfeydd Stryd (Ffioedd Archwilio) 1992 (O.S.1992/1688).

These Regulations provide for an increase from £15.50 to £20 in the fee payable by undertakers for inspections of their work by street authorities in Wales under regulation 3(1) of the Street Works (Inspection Fees) Regulations 1992 (S.I. 1992/1688).

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 75 a 104(1) o Ddeddf Ffyrdd Newydd a Gweithfeydd Stryd 1991(a), ac sy'n arferadwy gan y Cynulliad Cenedlaethol mewn perthynas â Chymru(b), drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred upon the Secretary of State by sections 75 and 104(1) of the New Roads and Street Works Act 1991(a) and which are now exercisable by the National Assembly in relation to Wales(b), hereby makes the following Regulations:

Enwi, cychwyn a chymhwyso

1. -(1) Enw'r Rheoliadau hyn yw Rheoliadau Gweithfeydd Stryd (Ffioedd Archwilio) (Diwygio) (Cymru) 2002 ac maent yn dod i rym ar 1 Ionawr 2003.

Citation, commencement and application

1. -(1) These Regulations may be cited as the Street Works (Inspection Fees) (Amendment) (Wales) Regulations 2002 and come into force on 1st January 2003.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru.

(2) These Regulations apply to Wales.

Cynnydd yn y ffi archwilio

2. Yn rheoliad 3(1) o Reoliadau Gweithfeydd Stryd (Ffioedd Archwilio) (Diwygio) 1992(c) amnewidir am y ffigur "£15.50" yno y ffigur "£20".

Increase in the inspection fee

2. In regulation 3(1) of the Street Works (Inspection Fees) Regulations 1992(c) there is to be substituted for the figure of "£15.50" there the figure of "£20".
