O dan adran 64(1) o Ddeddf Llywodraeth Leol 1972 (fel y'i hamnewidiwyd gan Ddeddf Llywodraeth Leol (Cymru) 1994) yr oedd yn ofynnol i Gomisiwn Ffiniau Llywodraeth Leol Cymru adolygu'r trefniadau etholiadol cyn gynted ag y bo'n ymarferol ar ôl yr etholiadau cyntaf i awdurdodau unedol ym Mai 1995.

The Local Government Boundary Commission for Wales was required by section 64(1) of the Local Government Act 1972 (as substituted by the Local Government (Wales) Act 1994) to review the electoral arrangements as soon as practicable after the first elections to unitary authorities in May 1995.

Mae'r Gorchymyn hwn yn rhoi ei effaith i'r cynigion a wnaed yn adroddiad Rhagfyr 1999 Comisiwn Ffiniau Llywodraeth Leol Cymru ar gyfer Bwrdeistref Sirol Casnewydd.

This Order gives effect to the proposals made in the Local Government Boundary Commission for Wales' report of December 1999 for the County Borough of Newport.

Er bod y Gorchymyn yn dileu pob adran etholiadol presennol yn y Fwrdeistref Sirol ac yn eu disodli ag adrannau etholiadol newydd, yn ymarferol bydd y mwyafrif ohonynt yn aros yr un fath.

Although the Order abolishes all existing electoral divisions within the County Borough and replaces them with new electoral divisions, in practice the majority of them will remain the same.

Mae'r trefniadau presennol yn aros yr un fath ar gyfer adrannau etholiadol **Allt-yr-ynn, Alway, Beechwood, Betws, Caerllion, Y Gaer, Y Graig, Llan-wern, Malpas, Pilgwenlli, Ringland, Tŷ-du, Shaftesbury, Sain Silian, Stow Hill, Parc Tredegar, Victoria.**

The existing arrangements remain for the electoral divisions of **Allt-yr-ynn, Alway, Beechwood, Bettws, Caerleon, Gaer, Graig, Llanwern, Malpas, Pillgwenlly, Ringland, Rogerstone, Shaftesbury, St. Julians, Stow Hill, Tredegar Park, Victoria.**

Cynrychiolir adran **Langstone**, sy'n cynnwys cymunedau **Langstone, Llanfaches** a **Phen-hŵ**, gan ddau gynghorydd.

The division of **Langstone** which comprises of the communities of **Langstone, Llanvaches** and **Penhow** will be represented by two councillors.

Mae adran etholiadol **Liswerry** i gynnwys cymunedau **Liswerry** a **Threfonnen** ac mae i'w chynrychioli gan bedwar cynghorydd. Ni fydd adran etholiadol Llan-wern felly yn cynnwys cymuned Treffonen.

Mae adran **Maerun**, sy'n cynnwys cymunedau **Coedcernyw**, **Maerun**, **Llanfihangel-y-fedw** a **Gwynllwg**, i'w cynrychioli gan ddau gynghorydd.

The electoral division of **Liswerry** is to comprises of the communities of **Liswerry** and **Nash** and be is represented by four councillors. The electoral division of Llan-wern will not therefore include the community of Nash.

The **Marshfield** division, which comprises of the communities of **Coedkernew**, **Marshfield**, **Michaelstone-y-Fedw** and **Wentlooge**, is to be represented by two councillors.

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Bwrdeistref Sirol Casnewydd (Newidiadau Etholiadol) 2002.

(2) Daw'r Gorchymyn hwn i rym:

- (a) at ddibenion achosion, sy'n arwain at unrhyw etholiad neu'n ymwneud ag unrhyw etholiad sydd i'w gynnal ar 6 Mai 2004, ar 9 Hydref 2003, a
- (b) at bob diben arall, ar 6 Mai 2004.

(3) Yn y Gorchymyn hwn -

ystyr "adran etholiadol" ("*electoral division*") yw un o adrannau etholiadol Bwrdeistref Sirol Casnewydd fel y'i sefydlwyd gan Orchymyn Trefniadau Etholiadol Bwrdeistref Sirol Casnewydd 1994(b);

ystyr "y Ddeddf" ("*the Act*") yw Deddf Llywodraeth Leol 1972.

In pursuance of sections 58(1) and 64 of the Local Government Act 1972(a) the Local Government Boundary Commission for Wales submitted proposals in December 1999 for the future electoral arrangements for the County Borough of Newport. The National Assembly for Wales, having agreed with the proposals, makes the following Order in exercise of the powers conferred on it by sections 58(2) and 67(4) and (5) of the Act:

**Name, commencement and interpretation**

1.-(1) This Order is called the County Borough of Newport (Electoral Changes) Order 2002.

(2) This Order will come into force:

- (a) for the purposes of proceedings, preliminary or relating to any election to be held on the 6th May 2004, on the 9th October 2003, and
- (b) for all other purposes, on 6th May 2004.

(3) In this Order -

"the Act" ("*y Ddeddf*") means the Local Government Act 1972;

"electoral division" ("*adran etholiadol*") means an electoral division of the County Borough of Newport as constituted by the County Borough of Newport Electoral Arrangements Order 1994(b).

### **Adrannau Etholiadol**

2.-(1) Diddymir adrannau etholiadol presennol Bwrdeistref Sirol Casnewydd a bennir yn yr Atodlen i Orchymyn Trefniadau Etholiadol Bwrdeistref Sirol Casnewydd 1994.

(2) At ddibenion ethol cynghorwyr ar gyfer Bwrdeistref Sirol Casnewydd, rhennir y Fwrdeistref Sirol honno yn 20 o adrannau etholiadol yn dwyn yr enwau a bennir yng ngholofn (1) o'r Atodlen i'r gorchymyn hwn, a bydd pob adran etholiadol o'r fath yn cynnwys yr ardal a bennir yng ngholofn (2) o'r Atodlen honno.

(3) Y nifer a bennir mewn perthynas â'r adran yng ngholofn (3) o'r Atodlen i'r Gorchymyn hwn fydd y nifer o gynghorwyr sydd i'w hethol ar gyfer pob adran etholiadol o'r fath.

### **Y Gofrestr o Etholwyr Llywodraeth Leol**

3. Rhaid i'r swyddog cofrestru wneud unrhyw addrefniadau neu addasiadau i'r gofrestr o etholwyr llywodraeth leol sy'n angenrheidiol am fod y Gorchymyn hwn yn dod i rym.

### **Electoral Divisions**

2.-(1) The existing electoral divisions of the County Borough of Newport specified in the Schedule to the County Borough of Newport Electoral Arrangements Order 1994 are abolished.

(2) For the purposes of the elections of councillors for the County Borough of Newport, that County Borough shall be divided into 20 electoral divisions bearing the names specified in column (1) of the Schedule to this order, and each such electoral division shall comprise the area specified in column (2) of that Schedule.

(3) The number of councillors to be returned for each such electoral division shall be the number specified in relation to the division in column (3) of the Schedule to this Order.

### **Register of Local Government Electors**

3. The registration officer shall make such re-arrangements or adaptation of the register of local government electors as may be necessary due to the coming into force of this Order.
