Mae'r Gorchymyn hwn yn diwygio Gorchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre (Sefydlu) 1993 (y prif Orchymyn) ymhellach er mwyn diwygio ei swyddogaethau a chynyddu nifer ei gyfarwyddwyr anweithredol.

This Order further amends the Velindre National Health Service Trust (Establishment) Order 1993 (the principal Order) so as to amend its functions and increase its number of non-executive directors.

Mae'r Gorchymyn yn estyn swyddogaethau'r ymddiriedolaeth i gynnwys swyddogaeth rheoli gwasanaethau sy'n ymwneud â thechnoleg gwybodaeth, gwybodaeth iechyd, telathrebu a rhagnodi a dosbarthu.

The Order extends the functions of the trust to include the function of managing and providing services relating to information technology, health information, telecommunications and prescribing and dispensing.

Mae'r Gorchymyn hwn yn diwygio'r prif Orchymyn ymhellach drwy gynyddu nifer y cyfarwyddwyr anweithredol o 4 i 6.

This Order further amends the principal Order by increasing the number of non-executive directors from 4 to 6.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd i Ysgrifennydd Gwladol Cymru gan adran 126(3) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977 (a), adran 5(1) a (6) o Ddeddf Gwasanaeth Iechyd Gwladol a Gofal Cymunedol 1990(b) ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru(c) wedi cwblhau'r ymgynghori a ragnodwyd o dan adran 5(2) o Ddeddf Gwasanaeth Iechyd Gwladol a Gofal Cymunedol 1990(ch), drwy hyn yn gwneud y Gorchymyn canlynol:

The National Assembly for Wales, in exercise of powers conferred on the Secretary of State for Wales by section 126(3) of the National Health Service Act 1977(a), section 5(1) and (6) of the National Health Service and Community Care Act 1990(b) and now vested in the National Assembly for Wales(c) after completion of the consultation prescribed under section 5(2) of the National Health Service and Community Care Act 1990(d), hereby makes the following Order:

Enwi a chychwyn

1.-(1) Enw'r gorchymyn hwn yw Gorchymyn Diwygio Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre (Sefydlu) 2002 a daw i rym ar 1 Ebrill 2002.

Citation and commencement

1.-(1) This order may be cited as the Velindre National Health Service Trust (Establishment) Amendment Order 2002 and shall come into force on 1st April 2002.

(2) Yn y Gorchymyn hwn, ystyr "y prif Orchymyn" ("*the principal Order*") yw Gorchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol (Sefydlu)1993 fel y'i diwygiwyd(d).

(2) In this Order, "the principal Order" ("*y prif Orchymyn*") means the Velindre National Health Service Trust (Establishment) Order 1993 as amended (e).

"(c)to manage and provide to or in relation to the health service in Wales a range of information technology systems and associated support and consultancy services, desktop services, web development, telecommunications services, healthcare information services and services relating to prescribing and dispensing .

Diwygio erthygl 4 o'r prif Orchymyn

3. Yn erthygl 4 o'r prif Orchymyn (Cyfarwyddwyr yr ymddiriedolaeth), am "4 non-executive directors" amnewidier "6 non-executive directors".

Amendment of article 3 of the principal Order

2. The principal Order shall be amended as follows:-
at the end of article 3(2)(b) add -

"(c)to manage and provide to or in relation to the health service in Wales a range of information technology systems and associated support and consultancy services, desktop services, web development, telecommunications services, healthcare information services and services relating to prescribing and dispensing."

Amendment of article 4 of the principal Order

3. In article 4 of the principal Order (Directors of the trust), for "4 non-executive directors" substitute "6 non-executive directors".
