Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) 1997 ("Rheoliadau 1997") a Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Offthalmig Cyffredinol) 1986 ("Rheoliadau 1986").

These Regulations further amend the National Health Service (Optical Charges and Payments) Regulations 1997 ("the 1997 Regulations") and the National Health Service (General Ophthalmic Services) Regulations 1986 ("the 1986 Regulations").

Mae Rheoliadau 1997 yn darparu ar gyfer cynllun taliadau i'w gwneud gan yr Awdurdodau Iechyd ac Ymddiriedolaethau GIG drwy gyfrwng system dalebau mewn perthynas â chostau a dynnir gan categorïau penodol o bersonau mewn cysylltiad â phrofion golwg a chyflenwi, amnewid a thrwsio cyfarpar optegol.

The 1997 Regulations provide for a scheme of payments to be made by Health Authorities and NHS Trusts by means of a voucher system in respect of costs incurred by certain categories of persons in connection with sight tests and the supply, replacement and repair of optical appliances.

Mae Rheoliadau 1986 yn cynnwys darpariaeth ar gyfer trefniadau gwasanaethau offthalmig cyffredinol o dan y Gwasanaeth Iechyd Gwladol.

The 1986 Regulations contain provision for the arrangements for general ophthalmic services under the National Health Service.

Mae **rheoliad 2** yn diwygio rheoliad 8 o Reoliadau 1997 er mwyn cynyddu gwerth y ffigur a bennir ynddo ar gyfer yr "amount withdrawn" o ddyfarniadau credyd treth teuluoedd sy'n gweithio a chredyd treth pobl anabl. (Mae'r ddarpariaeth hon yn cynyddu'r lefel incwm sy'n dod â'r rheini sy'n cael credydau treth yn gymwys i gael talebau optegol GIG).

Regulation 2 amends regulation 8 of the 1997 Regulations to increase the value of the figure specified therein for the "amount withdrawn" from awards of working families' tax credit and disabled person's tax credit. (This increases the income level at which recipients of the tax credits are eligible to receive NHS optical vouchers).

Mae **rheoliad 4(2)** yn diwygio Atodlen 2 i Reoliadau 1997 er mwyn cynyddu gwerthoedd ychwanegol talebau ar gyfer prismau, tintiau, lensys ffotocromig a chategoriâu penodol o gyfarpar.

Mae **rheoliad 4(3)** a'r Atodlen yn gosod Atodlen 3 newydd yn Rheoliadau 1997 er mwyn cynyddu gwerth talebau a roddir tuag at drwsio ac amnewid cyfarpar optegol.

Rhyw 1.95% yw cyfradd y cynnydd, ar gyfartaledd.

Mae **rheoliad 5** yn diwygio rheoliad 13 o Reoliadau 1986 er mwyn cynyddu gwerth y ffigur ar gyfer yr "amount withdrawn" o ddyfarniadau credyd treth teuluoedd sy'n gweithio a chredyd treth pobl anabl. (Mae'r ddarpariaeth hon yn cynyddu'r lefel incwm sy'n dod â'r rheini sy'n derbyn y credydau treth yn gymwys i gael prawf golwg GIG).

Yn **rheoliad 6** ceir darpariaethau trosiannol.

single contact lens, and to increase the maximum contribution by way of a voucher to the cost of repairing a spectacle frame.

Regulation 4(1) amends Schedule 1 of the 1997 Regulations to increase the value of vouchers issued towards the costs of the supply and replacement of glasses and contact lenses.

Regulation 4(2) amends Schedule 2 to the 1997 Regulations to increase the additional values for vouchers for prisms, tints, photochromic lenses and special categories of appliances.

Regulation 4(3) and the Schedule substitute a new Schedule 3 in the 1997 Regulations to increase the value of vouchers issued towards the repair and replacement of optical appliances.

The rate of increase is, on average, approximately 1.95%.

Regulation 5 amends regulation 13 of the 1986 Regulations to increase the value of the figure for the "amount withdrawn" from awards of working families' tax credit and disabled person's tax credit. (This increases the income level at which recipients of the tax credits are eligible to receive an NHS sight test).

Regulation 6 contains transitional provisions.

Citation, commencement, interpretation and application

1.-(1) These Regulations may be cited as the National Health Service (Optical Charges and Payments) and (General Ophthalmic Services) (Amendment) (Wales) Regulations 2002.

(2) These Regulations shall come into force on -

- (a) except for regulations 2 and 5, on 1st April 2002; and
- (b) regulations 2 and 5 on 9th April 2002.

(3) In these Regulations unless the context otherwise requires -

"the 1997 Regulations" ("Rheoliadau 1997") means the National Health Service (Optical Charges and Payments) Regulations 1997(a);

"the 1986 Regulations" ("Rheoliadau 1986") means the National Health Service (General Ophthalmic Services) Regulations 1986(b).

(4) These Regulations apply to Wales only.
